CIRCULAR

Sub: Delegation of Powers of State Government to the Administrator of UTs of Daman & Diu and Dadra & Nagar Haveli, under various Central Acts and of Government to the Administrator of UT of Daman and Diu under various laws enacted by the legislature of erstwhile Goa, Daman and Diu..

The Goa, Daman & Diu (Laws) Regulation, 1962 was promulgated by President of India to extend certain Laws, subject to modification, if any, as specified in the Schedule thereto, to the UT of Goa, Daman & Diu. Many other Central Laws were similarly further extended to the UT of Goa, Daman & Diu by promulgating the Goa, Daman and Diu (Laws) No.2 Regulation, 1963. The list of such Central Laws extended to the UT of Goa, Daman & Diu is enclosed with this circular as **Annexure-I**. The provisions of these Acts were to come into force on such date as the Lieutenant Governor, by notification in the Goa, Daman and Diu Gazette appointed. The extension of these Acts was also subject to the modifications, if any, specified in the Schedule to the respective Regulations. All Rules, Notifications, Orders, Regulation and Bye-laws made or issued by the Central Government under the provisions of these Acts also came into force from the commencement of the provisions of the Act in Goa, Daman and Diu.

- 2. As provided under clause (b) of sub section (1) of Section 6 of the Regulation ibid of 1962 and clause (b) of sub-section (1) of Section 7 of the Regulation of 1963, "any reference to the State Government shall be construed as a reference to the Central Government and also as including a reference to the Lieutenant Governor" i.e. the Administrator of Goa, Daman & Diu (as per definition u/s 2(c) of the respective Regulation).
- 3. Various Laws were similarly extended to the UT of Dadra & Nagar Haveli by promulgating the Dadra and Nagar Haveli (Laws) Regulation, 1963, the Dadra and Nagar Haveli (Laws) Regulation, 1965 and the Dadra and Nagar Haveli (Laws) No.2 Regulation, 1981. The list of such Central Laws extended to the UT of Dadra & Nagar Haveli is enclosed herewith as **Annexure II.**
- As provided under Clause (b) of Sub Section (1) of Section 5 of the Regulation of 1963 as also of 1981, any reference to the State Government shall, save as otherwise directed in the First Schedule of Regulation of 1961, be construed as a reference to the Central Government and also as including a reference to the Administrator.
- 5. The Ministry of Home Affairs, New Delhi vide letter No. U-11026/1/93-UTS dated 9/2/1996 has also clarified that,

- 2. "Under the Goa, Daman & Diu Re-organization Act, 1987 all the existing laws in force and applicable in the erstwhile Union Territory of Goa, Daman and Diu were allowed to be continued in the new Union Territory of Daman & Diu; all the authorities vested with powers under the relevant laws were continued to be so vested after re-organization. Accordingly, if the power of "Government" though used in various forms in various laws enacted by the legislature of erstwhile Goa, Daman and Diu was available with the Lieutenant Governor of Goa, Daman and Diu, it automatically becomes available to the Administrator of the new U.T. of Daman & Diu......"
- 6) In view of the above clarification issued by MHA and keeping in view the provisions of the Goa, Daman & Diu (Laws) Regulation, 1962 and the provisions of the Dadra and Nagar Haveli (Laws) Regulations 1963, it is evident that the powers of "State Government" under various Central Laws as annexed herewith at Annexure I & II and the powers of "Government" under various laws enacted by the legislature of erstwhile Goa, Daman and Diu, are vested with the Administrator of Daman & Diu/Dadra & Nagar Haveli, as the case may be.
- 7) This is for favour of information of Officers in the UT Administration of Daman and Diu and Dadra & Nagar Haveli.
- 8) It may be noted that this Circular is only clarificatory in nature and for guidance of Officers. For any specific case, Officers may refer to the relevant Regulation
