ORDER

- 1. WHEREAS, the elections for the various wards of Village Panchayats and District Panchayats in the Union Territory of Daman & Diu were held on 19.09.2010 under the provisions of Daman and Diu Panchayats(Amended) Regulation, 1994.
- 2. AND WHEREAS, vide Notification No.7-2/EC/DD/2010 dated 23rd September, 2010, the Election Commission of the Union Territory notified the names of members elected from various wards of Village Panchayat and District Panchayat, as were also republished in the Extraordinary Official Gazette of Union Territory Administration of Daman and Diu, vide Notification No.3/20/2010-11/DMN-PANCH/ELEC/(LB)/158 DATED 23.09.2010.
- 3. AND WHEREAS, as per provision of Section 21 of the Daman and Diu Village Panchayats (Amended) Regulation, 1994, each Panchayat shall continue for five years from the date appointed for its first meeting and no longer, when dissolved sooner under Section 52.
- 4. AND WHEREAS, Daman and Diu Panchayat Regulation 2012 has been promulgated vide Notification No.4/21/SPL.Sec(PRI)/2012-13/80 dated 16.08.2012 which has come into force on 17.08.2012.

- 5. AND WHEREAS, vide Notification No.3/50/SS(PRI)/SDP/DMN/2012-13/57 dated 17th July, 2013 under section 54 of the Daman and Diu Panchayat Regulation 2012, separate District Panchayats have been constituted for the two Districts of the Union Territory i.e. Daman District Panchayat for Daman District and Diu District Panchayat for Diu District, with immediate effect.
- 6. AND WHEREAS, section 55 of the Daman and Diu Panchayat Regulation, 2012 provides that the District Panchayat shall consist of such number of seats to be filled from such number of wards, as the Administrator may, by order, determine.
- 7. AND WHEREAS, due to lack of specific provision in the Regulation, a difficulty has arisen about determining the composition of separate District Panchayats of Daman and Diu Districts.
- 8. AND WHEREAS, section 124 of the Daman and Diu Panchayat Regulation, 2012 provides as follows:-
 - 124. 1. If any difficulty arises in giving effect to the provisions of this Regulation, the Administrator may by order published in the Official Gazette, as the occasion may require, do anything which appears to him to be necessary for expedient removal of the difficulty:

Provided that no such order shall be made after the expiration of two years from the commencement of this Regulation.

- 2. Every order made under this section shall be laid, as soon as may be after it is made before each House of Parliament.
- 9. NOW THEREFORE, in terms of powers conferred by section 124 of the Daman and Diu Panchayat Regulation, 2012, read with sections 55 and 61 of the said Regulation, it is ordered as follows:-
 - (a) The composition of Gram Panchayats and constituencies/wards in each District Panchayat shall be below :-

- (b) The following shall also be represented in Daman District Panchayat:-
 - (i) All the Sarpanchs of Gram Panchayats comprised in Daman District Panchayat
 - (ii) The Member of Parliament representing the constituency of the Union Territory
- (c) The following shall also be represented in Diu District Panchayat:-
 - (i) All the Sarpanchs of Gram Panchayats comprised in Diu District Panchayat
 - (ii) The Member of Parliament representing the constituency of the Union Territory
- (d) All the Members elected from various wards of Village Panchayat and District Panchayat notified vide Notification No.7-2/EC/DD/2010 dated 23/09/2010 of the Election Commission of the UT, as republished in the Extraordinary Official Gazette of U.T. Administration of Daman & Diu vide Notification No.3/20/2010-11/DMN-PANCH/ELEC/(LB)/158 dated 23.09.2010, shall continue as members of the respective Village Panchayat/District Panchayat for the remainder of the duration of their term.
- (e) The President and Vice President of the erstwhile Daman and Diu District Panchayat shall cease to hold office with immediate effect.
- (f) Election to the office of President and Vice-President of Daman District and Diu District Panchayat may be held in accordance with provisions of the Daman and Diu Panchayat, Regulation, 2012 and Daman and Diu Election of Upa-Sarpanch of a Gram Panchayat and President and Vice-President of District Panchayat, Rules, 2013.
- (g) The provisions contained in sections 55(5), 61(5) and 66 of the Daman and Diu Panchayat Regulation, 2012 related to reservation of seats for members of District Panchayat and the office of President shall not apply until the next elections are held to the wards of the District Panchayats.
