### 21.1 FREQUENCY OF PUBLICATION OF OFFICIAL GAZETTE OF U.T. OF DAMAN AND DIU :

- i) It is published in 3 series every Friday.
- ii) Extraordinary issues are published when necessary for official matters only and not for private advertisement.

Series –II	<ul style="list-style-type: none"> <li>i) Notifications of appointment, posting, transfer leave etc. of Gazetted Government servants.</li> <li>ii) Notifications, Orders, Awards etc. under various enactments such as Registration of Societies Act, Land Acquisition Act, Payment of Wages Act, Industrial Disputes Act, etc..</li> </ul>
Series –III	<ul style="list-style-type: none"> <li>i) Tender notices, miscellaneous notices, notices issued by Revenue Recovery Courts.</li> <li>ii) Notices issued by the Communicates.</li> <li>iii) Private advertisements which are required to be published as per statutory provisions.</li> </ul>

### **21.6 INSTRUCTION FOR SUBSCRIBERS :**
