O R D E R

In partial modification to Government order at preamble (1) above, the Village Panchayats of U. T. of Daman & Diu are hereby permitted to incur expenditure as under :-


- (a) Contingency expenditure up to ₹10,000/- (Rupees ten thousand only) in each case.
- (b) Works and repairs of expenditure up to ₹10.00 lakh (Rupees ten lakh only) in each case.

This Power shall be exercised by Panchayats, subject to conditions that the Technical Sanction for the works and repairs shall be obtained from the Competent Authority and also to follow all codal formalities as laid down under GFR, CTR, DFP Rules CPWD Works Manual Code & instructions/guidelines issued by GOI, MHA, MOF, Ministry of Rural Development, CVC, Planning Commission & UT Administration from time to time & also availability of funds. No deviation is permissible. Violence/lapse of any conditions, rules, instructions, etc. will be viewed seriously & erring officers/officials will be liable for disciplinary action.

This issues in supersession to earlier Order No.1/160/DC/Plan-Fin-Power/2008-09/247 dated 14/08/2008.
