(vi) Superintendent of Police, Daman & Diu	Red light without Flasher
(vii) District & Sessions Judge.	Red light without Flasher
(viii) Chief Conservator of Forest, Daman & Diu	Red light without Flasher

b). Govt. Motor Vehicle used by the:-

(i) Member of Parliament Daman & Diu in the capacity of Ex-officio Vice Chairman of U.T. level Planning Board.	Red light without Flasher
(ii) President cum-Chief Counsellor, District Panchayat, Daman & Diu.	Red light without Flasher
(iii) President, Daman Municipal Council, Daman	Red light without Flasher
(iv) President, Diu Municipal Council, Diu.	Red light without Flasher

c). The Administrator is further pleased to notify the following class of motor vehicles of Daman & Diu which can used Amber/Blue Lights on the top front of the vehicle

(i) Conservator of Forest, Daman & Diu	Amber light without Flasher
(ii) Commissioner of Excise/Sales Tax/Labour, Daman & Diu	Amber light without Flasher
(iii) Addl. District Magistrate, Daman & Diu	Amber light without Flasher
(iv) Sub Divisional Magistrate, Daman & Diu	Amber light without Flasher
(v) Addl. Superintendent of Police, Daman & Diu	Amber light without Flasher
(vi) Chief of Police. Daman & Diu	Amber light without Flasher
(vii) Police Vehicles	Amber light without Flasher
(viii) Fires Service	Amber light without Flasher
(ix) Enforcement vehicles of Transport and State Excise Deptt	Amber light without Flasher
(x) Mamlatdar, Daman & Diu	Amber light without Flasher
(xi) Medical Ambulance	Blue Light
