1. The Rates should be strictly for delivery at the School of Diu District.
2. The Rate should be quoted inclusive of all Taxes including Service Tax/
Packing /etc. wherever applicable
3. No extra charges for packing, forwarding & insurance will be paid.
4. The Rate should be quoted separately for each item alongwith specification
and mark of the manufacturer.
5. The Rate quoted will be valid and operative for a period of six months from
the date of acceptance of the tender.
6. The dealer should be Register with the VAT Department.
7. No advance payment will be made. However the payment of bills will be
released on completion and supply during the respective Schools.
8. The Supply order will be given after samples verified by the technical
persons as per Design.
9. The successful tenderer will have to deposit 10% of the total amount of the
tender as a security deposit before the Education officer, DP, Diu for the
period of six month.
10. The items which are not found satisfactorily as per design /approved sample
will be return to the supplier own cost.
11. No separate agreement shall require to be signed by the successful tenderer
for the purpose of contract for supply rate tender and the terms and condition
attached to the tender signed by the tenderer will be binding upon him for any
legal action purpose.

amount is more than Rs. 5000/- indicating invariable the number and date of
tender and supply order issued by the Education Officer, Diu.

of FDR of any Nationalized / Schedule Bank in favour of the Education
Officer, District Panchayat, Diu shall be submitted in the Sealed Envelop
