**TERMS AND CONDITION FOR THE PURCHASE OF MIXED
VEGETABLE AND FRUIT (BANANA) FOR**

THE MID DAY MEALS SCHEME OF DIU DISTRICT

OPEN TENDER NOTICE NO. EDN/DP/MDM/DIU/2009-10/356

- 1) The rate(s) quoted should be strictly for free delivery at the schools / MDM Centers in Diu District. Fresh vegetable and Fruits should be supplied to the MDM Centers in Diu District on daily or as per instruction given by this office .
- 2) The rate should be quoted inclusive of all taxes .
- 3) No taxes /duties payable on the sale / transport etc within and or outside the state of the supplier shall be payable by the supplier only.
- 4) All supply bill shall contain the following Certificate “ Certified that the goods on which Tax has been charged have not been exempted under the Central Sale Tax , or the rule made there under , and the amount charged on account of Sale Tax on these goods is not more then what is payable under the provision of relevant act or the rules made there under.
- 5) No extra charges for packing , forwarding and insurance etc. will be paid.
- 6) The rate should be quoted separately for each items as Quality mention in tender form..
- 7) In case of failuar to supply of MIXED VEGETABLE AND BANANA as per the condition and within the stipulated time the same will be awarded to the next second lowest and the loss to govt. on this account **shall be recovered from former suppliers , security deposit / earnest money.**
- 8) The suppliers will have to supply the Vegetable / Banana to the various Schools at Diu District at their own cost as per list issued by the Education Officer , District Panchayat, Diu.
- 9) All bills should be in duplicate and invariable mentioned the numbers and date of the Tender and supply order of Education Officer , District Panchayat, Diu.
- 10) The tender with over-writing or erasing works will not be considered.
- 11) The decision of Chief Executive Officer, (District Panchayat) Daman & Diu,
Daman for acceptance / rejection of Tender shall be final.

- 12) (a) The E.M.D. may be drawn in favor of **Education officer, (DP), Diu** as under
- (1) Rs. 77,000/- for purchase of mixed vegetable (As per Annexure – I)
 - (2) Rs. 53, 000/- for purchase of Banana. (As per Annexure – II)
- (b) Tender received without E.M.D. will be rejected.
- 13) The amount of earnest money paid by the tenders, whose tender is not acceptable will be refunded to them.
- 14) The blank tender form for Vegetable / Fruit items shall be made available to the interested parties on payment of Rs.500/- in case each tender form (Non refundable) in the office of the Education officer , District Panchayat , Diu on all working day from 27 / 07 / 2009 to 07/ 08 / 2009 up to 17.00 Hrs.
- 15) Last date for receipt of Tenders forms duly filled is 10/ 08/2009 up to 03:00 P.M. and it will be open on the same day at 04.00 P.M. if possible in the Office of the the same day at 04.00 P.M. if possible in the chamber of the Block Development Office, District Panchayat , Diu in the presence of the Tender committee and Tenderers or their representatives , if any.
- 16) No. separate agreement will be required to be signed by the successful Tender (s) for the purpose of the contract for supply rates tendered /offered in responses to the concerned tender / notice shall be considered as acceptance of all above terms and conditions for supply for all legal purpose.
- 17) No advance payment will be made . Payment to contractor /s shall be made by crossed Cheque A/C payees after passing the bill .
- 18) The contract will be for a period of **one year** from the date of acceptance of Tenders.
- 19) The terms and condition in original duly signed by the contractor / supplier is to be attached with Tender documents.
- 20) Materials should be supplied from time to time as and when required.
- 21) The ANNEXURE items which are not found satisfactory and in accordance to the Specification same will be returned and to be replaced at the supplier's own cost. Failing to do so supply order will be cancelled and shall be passed on to next lower quoted Agencies and in future said agencies will not be eligible for any supply to this department.

- 22) Supply Order will be issued only after rate approved by the competent authority.
- 23) The right to accept or reject without assigning any reasons any / or all Tenders in part of whole is reserved with the Chief Executive Officer, (District Panchayat), Daman and Diu , Daman and his decision on all matters relating to acceptance or rejection of the Tenders as a whole part will be final and binding all.
