1. Eligibility Criteria for tenderers:-

Only such contractors need apply, who have:-

- a) Total turn over for execution of similar type of work valuing one and a half of the cost of work, during preceding three years (from the date of opening of tenders).
- b) Executed, satisfactorily at least one work of a similar nature valuing half of the cost of work during preceding three years (from the date of Opening of tender).
- c) Financial solvency of 25% of the cost of the work issued by the state Bank of India or Nationalized Bank or Schedule State Co-Operative. Banks.

Tenderers should submit strict documentary proof, in regard to these qualifying criterias along with their applications demanding blank tender forms. The application of tenderers who either fail to submit required proof or do not meet the requirements mentioned (a) to (c) above, will be summarily rejected. The enlistment/registration of a contractor shall, only, entitle him to be considered for issue of tender papers subject to the conditions laid down herein above, and it shall not confer any right on him either to be necessarily issued the tender papers or award of work.

The intending contractors should submit their applications in prescribed form available in the office of the **Area Manager, Goa-IDC, Hotel Anmol Building, First Floor, Sea face Road, Daman – 396 210.**

The application in prescribed forms shall be received by the office of the **Area Manager, Goa-IDC, Hotel Anmol Building, First Floor, Sea face Road, Daman** from the contractors alongwith the required documents from 30/10/2009 to 05/11/2009 upto **4.00 p.m.** and tender documents will be issued to the eligible contractors by him on **06/11/2009 upto 5.00 p.m.**

The experience certificate and list of works in hand/carried out by the firm/contractor will have to be produced by the contractor, duly certified by the competent authority who is applying in this office for tender form. The Earnest Money Deposit will be accepted either in cash or in the form of Govt. Securities and fixed deposit receipts and guarantee bonds of scheduled banks and State Bank of India.
