1. Sealed tenders from the registered supplier having Food Licence from the Competent Authority are invited by the Director of Medical & Health services, Community Health Center, Moti Daman on behalf of the President of India, hereinafter called as the Government for the supply of Dietary items as per Annexure enclosed herewith.
2. The tender should be superscribed on the Envelop "Tender for Dietary Items".
3. The tender will be accepted during working hours upto 30/03/2010 at 11.00 a.m. and open on same day at 12.30 p.m., if possible in the office of the Director of Medical & Health Services, CHC Moti Daman in the presence of the Purchase Committee and tenderer(s) or their representative(s) if preset.
4. The Tenderer should send along with tender an amount of Rs.10,000/- (Rupees Ten thousand only) as Earnest Money in form of Demand Draft / F.D.R. of any Nationalized/ scheduled Bank payable at Daman in favor of the officer inviting tenders i.e. Director, Medical & Health Services, Daman. The E.M.D. submitted other than form mentioned above will not be accepted. Tender received without Bid Security will be summarily rejected.
5. Tenderers should quote their rates in the accompany proforma in figures as well as in words. The rates should be quoted separately to deliver items at the site of the shop of the tenderers. Any correction in the tender documents should be duly authenticated by full signature of the tenders. If the tenderer desires to furnish any additional information it may be furnished in separate sheets attached to the tender forms duly signed by the tenderer. The schedule of the rate should duly signed.
6. The right to accept or reject without assigning any reasons any or all tenders in part whole is reserved with the tender inviting officer and his decision(s) on all matters relating to acceptance or rejection of the tenders as a whole or in part will be final and binding to all
7. The successfully tenderer will give to pay security deposit of a sum of Rs. 2000/- initially and in addition pay by deduction at 10% of the amount of the bills for the supplies made from time to time as security for satisfactory completion on the supply and sign an agreement bond for the proper performance of the contract within three days of the communication of acceptance of the tender, EMD deposit for this tender can be adjusted towards security deposit if the tenderer so desires.
8. Non receipt of Security Deposit within stipulated time limit will result in automatic cancellation of the order for supply without any intimation.
9. The Articles of the first quality will be preferred and should correspond with the Government of India grading of any available for the items such as AGMARK, ISI mark etc.
