Terms and Conditions for Purchase and Installation of Surveillance System at OIDC IMFL outlets for the year 2009- 2010.

Tender Notice No. :- O IDC/07/DMN/IMFL/2009-2010/

The conditions of the tender are as under :

1. The tender should be in a sealed envelope subscribed as “TENDER FOR SUPPLY AND INSTALLATION OF SURVEILLANCE SYSTEM”.
2. The tender form along with terms and conditions can be obtained from the Office of the General Manager (Finance), O IDC Corporate Office. Tender notice is also available at website www.oicd.nic.in.
3. The rate(s) quoted should be strictly for free delivery at Daman, Diu and Silvassa O IDC IMFL outlets. No extra charge for packaging, forwarding and insurance, transportation etc will be paid.
4. Only Sales Tax / VAT will be paid on the items on which it is chargeable under the Central Sales Tax Act / VAT Act or the Rules made there under.
5. Copy of the Sales Tax Registration should be attached to tender.
6. The rate(s) should be quoted only for the items specified in the list of requirement and should be for the items of given special make / manufacture.

- 7.** Rate(s) quoted for items other than the required specification/make/manufacture may not be considered. However, indigenous manufacturers may quote their own makes provided the specifications confirm to the standard(s) / requirements of the given specification/make/manufacture.
- 8.** The General Manager (Finance), Daman will be at liberty to accept the tender for the entire quantity or the part thereof at the rates submitted by the bidder or at reduced rate during the negotiations if any.
- 9.** Where specification/make/Manufacture is not specified by this office, the rate(s) should be quoted only for the standard quality.
- 10.** The tenderer should specify the name of the manufacturer for the items quoted by him along with catalogue of the items.
- 11.** The tender should be neatly typed only on letterhead carrying the name of supplier and the signature of the tenderer. No overwriting, correction or erasing will be considered.
- 12.** The rate(s) must be inclusive of 05 years onsite warranty from the date of supply and installation.
- 13.** Successful bidder will have to sign an agreement with the purchaser within 05 days of the receipt of the supply order.
- 14.** Items supplied by the successful tenderer shall be randomly checked & verified by the Tender inviting Officer through Departmental staff/authorized staff. Acceptance item shall be strictly subject to satisfaction of the verifying authority.
- 15.** Payment shall be made only after acceptance of items and verification by the authority.
- 16.** Rates tendered / offered in response to the concerned Tender Notice by the successful bidder shall be considered as acceptance of all above terms and conditions for supply for all legal purpose.

17. The Earnest Money Deposit (E.M.D) of Rs. 15,000.00 is payable in form of Demand Draft issued by the Scheduled Bank in favour of **OIDC Ltd., Daman**. Tender received without EMD will be treated as invalid.
18. The amount of Earnest Money Deposit paid by the Tenderer(s) whose tenders are not accepted will be refunded to them within 03 days.
19. The amount of EMD paid by the successful Tenderer will be adjusted against the amount of Security Deposit to be paid by the successful tenderer.
20. The Tender will be received upto 4.00 p.m. on 15.03.2010 in the office of the General Manager (Finance), OIDC Corporate Office, Plot No. 35, Somnath, Nani Daman. The tender will be opened at 05.00 p.m on the same day if possible.
21. The call shall be attended within 24 hrs. of intimation failing which will attract levy of penalty equal to @ Rs. 300/- per outlet per call will be deductible / recoverable for each day's delay beyond 01 day in attending the call and in setting the system in order.
22. The supply and installation should be executed within 15 days from the date of supply order, failing which EMD of Rs. 15000/- will be forfeited to OIDC.
23. All bills should be in DUPLICATE and should invariable mention the number and date of supply order.
24. All bills for amount above Rs. 5,000.00 should be pre-receipted on a Revenue Stamp of proper value. Bills for amount exceeding Rs. 5,000.00 not pre-receipted on Revenue Stamp of proper value will not accepted for payment.
25. Each bill in which VAT is charged must contain the following certificate on the body of the bill.
“CERTIFICATE that the goods on which Value Added Tax has been charged have not been exempted under the Central

Sale Tax Act or the Rules made there under and the amount charged on account of Value Added Tax on these goods is not more than what is payable under the provisions of relevant Act or Rules made there under.”

- 26.** In respect of any dispute given rise to the legal proceedings between the parties, the courts at Daman shall alone have the Jurisdiction.
