
**LIMITED TENDER NOTICE**

Sealed tenders are hereby invited on behalf of the Agriculture Section, District Panchayat, Daman & Diu, from the individuals/ agencies having expertise in the field of setting up, operation & repair of Green/ Shed Net Houses for the works as detailed below:

**Terms & Conditions:**

1. The interested parties should quote their offer/ rates on their letter head or plain paper with their signature & seal. Prior making an offer, the interested parties are advised to inspect the existing conditions of the Green/ Shed Net Houses to be maintained.
2. The interested parties should have at least three years experience in the field of setting up, operation & repair of Green/ Shed Net Houses.
3. The maintenance work is to be done till 31<sup>st</sup> March, 2013. The offered rates should be inclusive all taxes & valid up to 31<sup>st</sup> March, 2013.
4. The maintenance work includes repairs/ replacement to structural parts/ plastic sheets/ shed net/ fittings, formation/ alteration/ addition/ deletion of planting beds along with planting medium and repairs/ replacement of spares of irrigation system, fan/ pad system as required or as may be directed from time to time. The Successful Tenderer shall have to bear all the costs on maintenance including repairs & replacement of material/ tools/equipments/ spare parts/ labour, etc.
5. The maintenance should be continued till 31<sup>st</sup> March, 2013, so as to keep all assets in working condition. All the repairs and replacements should be done in time bound manner, as & when required by the Department.
6. The materials/ tools/ equipments/ spare parts, etc. to be replaced should conform to the specification given by the department. The materials/ tools/ equipments/ spare parts, etc. which are not conforming to the given specification will be rejected and the Successful Tenderer shall have to replace the same within specified period of time.
8. The EMD, shall be furnished in the form of valid FDR or DD drawn in the name of Chief Executive Officer, District Panchayat, Daman & Diu, Daman and the same should be Enclosed with sealed tender. Tender received without enclosing specified EMD, if demanded, shall be rejected. EMD of the Successful Tenderer will be retained till Sixty days from 31<sup>st</sup> March, 2013. EMDs of the unsuccessful Tenderers will be released to them within 30 days from the date of opening of Tenders.
9. The successful Tenderer shall have to pay the Security Deposit & Performance Guarantee to the extent of 5% of the Cost of Tender in each case. The Security Deposit will be returned to the successful Tenderer within sixty days from 31<sup>st</sup> March, 2013 and the money deposited against Performance Guarantee will be returned within Six months from 31<sup>st</sup> March, 2013.
10. If the Successful Tenderer fails to fulfil his obligations as per terms and conditions of the Tender Notice and Work Order issued thereupon, his EMD, Security Deposit & Performance Guarantee shall be forfeited to the Government. The Department shall also have the privilege to use all such ways & means to protect the interest of the Government
11. The payment will be made in two stages, in equal proportions, only after completion of works assigned for the preceding quarter, to the satisfaction of this office.
12. The interested Tenderers should be registered with VAT Department.
13. Applicable taxes, if any, will be deducted from the final bill of the Successful Tenderer as per the I.T. Rules.
14. The tenders should reach this office up to 12.00 A.M. on 25 / 09 / 2012 in the sealed envelope super scribed as "Tender for Maintenance of Green/ Shed Net Houses" and it will be opened on the same day at 04:00 P.M. in presence of the Tenderers or their authorized representatives, if any, if possible.
15. The terms and conditions of this notice and, also further prescribed by this office shall be acceptable to the interested parties. No separate agreement will be executed for the purpose.
16. Right to reject or accept any or all tender is reserved with the Chief Executive Officer, District Panchayat, Daman & Diu, Daman.
17. All the disputes arising out of this business are subject to the jurisdiction of the appropriate Court/ Authority in the Union Territory of Daman & Diu.
