- 1. The upset price for the tender is Rs. 35,000/-. The intended tenders are required to quote the rates above the upset price.
- 2. The tender shall be given on plain paper and submitted in the name of Zonal Agriculture Officer, Daman in a sealed cover super scribed as "Tender for Sale of Mango Fruits".
- 3. The intended tenderder is required to deposit an amount of Rs. 1000/- in the form of FDR/Demand Draft drawn in favour of the Zonal Agriculture Officer, Daman along with the tender as "Earnest Money Deposit". Failing which, the tender will not be accepted.

- 7. The Mango Orchard is open for the inspection by the intended Tenderer (s) between 10:00 Hrs to 17:00 Hrs on any working day, however, with prior permission of the I/c of Govt. Seed Multiplication Farm, Kachigam. The I/c of Govt. Seed Multiplication Farm, Kachigam has authority to deny such permission for the reasons not to be explained to the intended Tenderer (s).
- 8. No any kind of damage shall be caused to the trees and other property of the Farm during harvesting and post-harvest operations.
