- 3. Financial Bid (only price against tender item) is required to prepare separately and submit on-line on website <a href="https://daman.nprocure.com">https://daman.nprocure.com</a>. Financial Bid in physical format shall not be accepted in any case.
- 4. Tender Fees of ₹ 1,000/- (Non-Refundable) and E.M.D. of ₹ 50,000/- (Refundable) in form of DD/FDR drawn on any Scheduled/ Nationalized Bank in favour of Superintendent of Fisheries, Daman in original (in physical form) shall be done by R.P.A.D./Speed Post/By Hand Delivery in the office of the Superintendent of Fisheries, Fisheries Department, Daman as per prescribed dated, time & venues as mentioned in the E-Tender Notice. - 5. In First instance, Technical Bid of all the bidders will be verified & if found to be satisfactory thereafter the Financial Bids of the eligible Tenderers only will be considered for the said Tender.
- 6. Tenders received after due date and time mentioned above will not be accepted.
- 7. The Supdt. of Fisheries, Daman reserves the rights to accept or reject any tender without assigning any reason.
- 8. Tender incomplete in any respect or conditional Tender will not be accepted..
- 9. The submission of E.M.D. is compulsory for all the tenderers and no exemption will be granted for submission of E.M.D. in any case.
- 10. Bid securities of the unsuccessful bidders will be returned after expiry of the final bid validity on or before the 30<sup>th</sup> days after award of the contract.
- 11. Bid securities of the successful bidder FDR will remain valid for a period of sixty days beyond the date of completion of all contractual of the supplier.
- 12. The Head of Office will consider extension of time for remitting the Security Deposit as demanded. However, in case of detail to consider such extension, the supplier is bound to abide by the limit given and liable to make good any loss to the Government on account of his failure to abide by the time limit stipulated.
- 13. The goods shall be nicely packed so that no damage is caused in transportation.
- 14. In case of failure to replace the non-accepted and rejected articles from supplies made as mentioned in the conditions, the loss undergone by the Government will be recovered from the supplier's Security Deposit / Earnes Money or payment due of any bill(s) to the extent required.
- 15. The supplies of equipment etc. of inferior quality / standard or of different specification other than that ordered specified and/or incomplete or broken articles will not be accepted. The supplier will have to replace the same at h own cost and risk. Intimation of non-acceptance of any stores, machinery and equipment etc. will be sent to the supplier within 15 days from the date of receipt of the stores, machinery and equipment will be returned to the supplier at his own cost and risk, if he so desires and intimates accordingly within 15 days from the date of despate

of intimated accordingly within 15 days from the date of despatch of intimation of the non-acceptance. However, if no communication is received within 15 days from the date of communication in the Tender Inviting Officer will not be responsible for any damage, loss, etc. of such rejected articles.

- 16. In case of failure to supply the stores, machinery and equipment, etc. ordered for as per the conditions and within the stipulated time, the same articles will be obtained, if required from the tenderer who offered next higher rates or from any other sources, as may be decided by the Tender Inviting Officer and the loss to the Government on account of such purchase(s) shall be recovered from the supplier's Security Deposit/Earnest Money Deposits or bills payable. The suppliers shall have no right to dispute with such procedure.
- 17. If at any time after the order for supply of Stores, Machinery & Equipment, the Tender Inviting Officer shall for any reason whatsoever not require the whole or part of the quantity thereof as specified in the order. The Tender Inviting Officer shall give notice in writing of the fact to the supplier(s) who shall have no claim to any payment of compensation whatsoever on account of any profit or advantage which the supplier(s) might have derived from the supply of articles in full, but which did not derive in consequence of the full quantity of articles not having been purchased, nor shall have any claim for compensation by reasons of any alterations having been made in the original instructions which shall involve any curtailment of the supply originally contemplated.
- 18. The bidder should provide layout of building plan required for installation of "Solar Fish Drier Plant with electrical backup" and other related accessories along with the Technical Bid.
- 19. Details of duration and temperature to be maintained to dry the specified fish should be provided along with the Technical Bid.
- 20. The successful bidder shall have to install the "Solar fish drier plant with electrical back up" and hand over the plant to Supdt. of Fisheries, Daman in running condition which should be able to dry the locally available fish i.e. Bombay duck, prawns, anchovies, ribbon fish etc. and demonstrate with satisfaction the process of drying of locally available fish and ensure the quality and standard of dried fish. No payment shall be made, if the Solar fish drier plant fails to dry the locally available fish upto the satisfaction of Fisheries Department.
- 21. The successful bidder shall provide 2 months training to the departmental staff and stake holders for processing of fish drying, general handling of plant, general maintenance, Technical Sustainability by repeated extensive training for stake holders & longer period of machinerary maintenance.
- 22. The Bidder will provide 1 year warranty/guarantee on all the components and provide free of cost maintenance (including spare parts).
- 23. All bills should be in DUPLICATE, pre-receipted on a Revenue Stamp of proper value, and should invariably mention the number and date of supply order.
- 24. Each bill in which Sales Tax / VAT is charged must contain the following certificate on the body of the bill.
- "Certified that the goods on which Sales Tax / VAT has been charged have not been exempted under the Central Sales Tax & VAT Act or the Rules made there under and the amount charged on account of Sales Tax on these goods is not more than what is payable under the provisions of relevant Act or the Rules made thereunder".
- 25. The rate should be F.O.R. concerned Supdt. of Fisheries, Daman and should include excise duty, sales tax, Freight charges, any other taxes rates of imposition whatever liable in respect of the supplies. The Supdt. of Fisheries, Daman shall not be liable to pay any tax, freight etc. which has been expressly stipulated in the tender in the event of acceptance of the tender.
