



**LIMITED TENDER NOTICE**  
**(Re-Tendering)**

1. Limited Tenders are invited from interested dealers by the Principal, Government Higher Secondary School, Bhimpore Daman on behalf of the President of India for supply of food grains, pulses, oil, grocery items etc. As per annexure for tribal students one Ashramshala functioning at Bhimpore, on quarterly basis.
2. Last dated for receipt of limited tenders in the office of the Principal, Government Higher Secondary School, Bhimpore Daman is 27/8/2014 ( up to 11.30 a.m.) and will be opened on 28/8/2014 at 11.30 a.m. if possible in the office of the Principal, Government Higher Secondary School, Bhimpore Daman in the presence of the purchase committee and tenderer(s) or their representative(s) if present.
3. The Tenderer should send along with tender by as an Earnest Money deposit equivalent to 2.5% of the total tendered value in the form of deposit at Call Receipt/fixed Deposit Receipt drawn on the State Bank of India or any other Scheduled Bank of Daman in favour of the Principal, Govt. Higher Secondary School, Bhimpore, Nani Daman.
4. The rate should be inclusive of transportation charges and all taxes for supply of food grains, pulses, oil, grocery items etc. to the Ashramshala every quarter. Sample of all items except specified brand should be sent along with tender. Supply order will be issued quarterly.

6. The dealers who have registration with CST/VAT are only required to submit their tenders otherwise summarily rejected.
7. The tenderers are required to produce/attach the following documents with tender in addition to above mentioned documents.

  - ii) A copy of VAT/ST Registration.
