#### 1. Invitation for Proposal

Sealed Bid under two bid systems are invited from prospective companies /firms /bidders, strictly in accorded with this scope of work, terms & condition, eligibility criteria etc. as mentioned in this tender documents. This is a turnkey project and bidders are requested to quoted for entire products and services, failing which, their bid will be rejected. Bidders are requested to study this documents carefully, before submitting their offer, and ensure that they have clearly understood the purpose of this Tender Invitation.

#### 2. Scope of Work

#### Schedule A

### Tablet based webcasting

Deployment of webcasting solution using Tablets with in-built camera and battery backup, at all the Polling Station on the day of the Election (Lok Sabha GE-2014). The following is the work to be carried out by Vendor for the successful execution of the live webcast and its recording:

- (a). Bidder/Vendor/OEM should act as single TSP to organize project in terms of:
  - Supply hardware (tablet-pc with in-built camera having appropriate ports for provide connectivity through wireless internet connection or 3G enabled SIM card) for all the Polling Station from starting of Poll process to end of Poll and counting process on the day of counting along with min. 2 hours battery backup.
  - Include installation and commissioning of technology for conducting live webcasting.
  - Imparting online training of operation of all items of the system to the technical manpower at the Polling Booths' level as well as the District level authorized officials during the time of installation and troubleshooting of all issues cropped up in the webcasting technological system.
  - 4. Provide recordings of webcasting of the Elections from all the polling booths one in external hard-drive.
  - The Vendor/Bidders shall provide a stand to place the tablet at the polling station for uninterrupted recording and transmission.
  - 6. The vendor shall 2 contact number per districts for a better support during the election monitoring.
  - The vendor shall provide full telephonic support 1 day prior testing from the polling stations.
  - (b). All hardware supplied by Vendor/Bidder/OEM should be of the best quality of their respective kinds and should be free from faulty design, workmanship and materials. In the context, please provide the complete specifications of the same with ancillary peripherals, if any.
  - (c). Vendor/Bidder/OEM should provide URL along with username and password as per need, for viewing the live webcasting of election activities to be done at all pooling booths.

#### Schedule B

#### IP camera based webcasting

The objective of webcasting through IP camera based webcasting is to explore optional technology. The Collector/DEO reserve full right to use either IP camera based solution or Tab based solution at any or all the polling station chosen therefore depending upon the principles of economy, technical feasibility and practicability. The bidder shall provide:-

- (a) IP based low light indoor camera with:
  - Minimum 32GB memory for edge recording
  - Support minimum sensor resolution of 1280 X 1024
  - Support image frame rate (minimum) of 30FPS @ 116 X 120, 30FPS @ 320 X 240, 30FPS @ 640 X 480, 10FPS @ 1024 X 768,
  - 1/4" progressive CMOS sensor
  - Supported video resolution 1.3m: 1024X768 512X384 256X192: 0.3M: 640X480 320X240 160X120
  - (Samba client) Recording to NSA directly, 3GPP support, UPnPAV support, WAP support, H/W Motion Detection
  - · Preferably onvif supported.
- (b) Camera viewing license
- (c) Static IP based broadband connectivity, minimum 256KBPS upload per camera. However, bidder to decide the bandwidth requirements per camera and quite accordingly.
- (d) One 20MBPS internet link at control room CEO, Daman & Diu office with a redundant link.
- (e) Webcasting software.

- (f) Bidder to install UPS or equivalent power source inbuilt 2 hrs backup at each location for powering each camera and broadband routers. For PSs without power supply (which would be rare), alternative power source like invertor or UPS should be provided for fully day recording
- (g) Manpower to configure and install camera and internet equipment at each polling location, as directed by the office of DEO
- (h) Bidder to provide secured network and ensure that footages created from these cameras is /are not leaked.
- (i) The webcasting software shall allow at least three concurrent viewing of same cameras from three different locations.
- (j) The bidder shall provide setup at each CEO, DM/DC & IGP office for their viewing of their own constituencies.

The camera shall be directly connected to ADSL CPE to any broadband with static IP. The suggested bandwidth per camera is 256KBPS upload (however, bidder to estimate the actual requirements). The video output of the camera will be streamed directly to State HQ/ Control/ Room. Recording at the polling booth shall be in the memory card of the camera directly.

At the State HQ/Control Room, a video wall is required to be set up by the bidder to all polling station and display unit will be used to view image from all the camera.

The Bidder shall install video monitoring & camera control software, so that multiple cameras can be viewed at a time. If required, the software shall enable operator to enlarge, freeze, records to take snapshot.

Bidder shall install terminate / install multiple internet link to firewall on Lad Balancing and failover mode. Bidder shall connected all the consol PC shall be connected to firewall through central switching console / gigabit Ethernet switch. The console pc shall have dual display card, one to be connected to monitor and another to video switch. (Video switch shall be used to toggle streams of different cameras).

Bidder shall install NAS at control room for recording purpose. It is recommended that minimum 32 TB of usable storage, with RAID 0, 1 & 5 be installed per 1000 camera recording.

# <u>Scheduled C</u> Vehicle based Election Monitoring

#### Bidder shall provide:-

Vehicle based live streaming solution at places directed by the CEO office.

Tab or IP based camera.

The tab/camera that shall be mounted on the vehicle.

Network video recorder -which should supported video streaming with multiple SIM cards;

It should support view on local LCD in side vehicle and control the camera.

It should support auto local recording in case of internet loss for up to 8 hours of storage.

Pre-installed application which will auto start on the time of event and will also auto recover in case of internet connectivity loss and reestablishment.

Live streaming shall support minimum speed of as low as 100 kbps.

Minimum 600 MBps in /out bandwidth shall be on the cloud.

Primary server shall be located in India/(Daman).

Cloud site and disaster recovery site shall completely separate from one another.

Shall include completed failover setup for VMS cloud.

## Scheduled -D Mobile live Tracking System

The scope of the project is to create a GIS based application. The application should enable office of the CEO,DEO, IGP and SP to monitor the polling procedure taking place in different polling booths, through sector officer.

The application should be:

- Web based application
- Mobile based application.

The mobile based application should be connected with the web application, i.e. both the application will run in parallel. The application should enable the sector officer to prepare various report / log of visiting polling station safely before the election on the day of polling, completion of the election procedures including mock poll, two hourly polling report to DEO and CEO office, reporting back to the receiving centre after polling is over, cases of EVM failure arise, polling restoration and status on disruption due to law and order or other reasons at the polling stations.

#### Feature of the Mobile application:

- The Mobile application should have tabs to send one touch information.
- The mobile application should multiple picture upload capacity picture can be uploaded from the gallery or by directly taking picture by the phone camera.
- The application should be able to store latitude longitude values of the phone at periodic time intervals.
- The application should send the location data to the cetral server using GPRS/ mobile internet / wi fi
- The application should be built to run on Android 4.0 and above operating systems.
- · The application should use sql as database
- The application have offline data storage capability. In case of problem in internet access data can be stored in the device itself.
- Later when internet comes the application should automatically update the data on the central server.
- There should be provision to lock the app from remote central location in case of any emergency.

#### Feature of Web application:-

- The application will be online application and should be accessible from anywhere using internet connection.
- The application should have real time sync with the central server and the mobile application.
- The application should have be GIS application showing the polling booth under particular PC.
- The GIS application should be developed using Google Maps API.
- The system should have tracking mode where live tracking of sector officers / mobile phone can be
- · The application should tracking based on different time periods.
- The application should be developed in . net language and should have SQL server 2008 as database.
- The system should automatically refresh in short periodic intervals.

#### Implementation

The software will be hosted by the Bidder. Server Hosting cost should be provided by the bidder for 3 months.

The Bidder has to provide 2 Manpower for training and support at both district of this constituency / locations as required.

The Manpower should be given for 3 days.( 1 days before and on the Polling Day)

The Rate should be quoted inclusive of all, Boarding, Loding, Fooding and Transfers.

The manpower should be capable enough to train voting official and handle situations.

#### 3. Supply Period

- (a) Bidder should supply hardware within four weeks which should be in good condition and a list of serial numbers of these hardware (Tablet PCs) to the Stores of the Election Department.
- (b) Deputing Engineer for 3 days till polling process and counting process is over on the poll day and counting Day, who should be well qualified to handle technical problems of selected polling booths and getting progress from the Technical Manpower at the selected polling booths, imparting training well in time to the booth level Technical Manpower as well as the district level Technical Manpower so that they can seamlessly conduct the assigned work of live webcasting from these booths. In the context please attach its detailed resume looking to the managing, coordinating & conducting the awarded project especially.
- © Primary recording of webcasting of the Election from the selected polling booths, in hard drive soon after the voting process is over at these booths. This should handed over to the CEO, UT of Daman & Diu.

#### 4. Payment Terms and conditions

- a) No advance payment shall be made.
- b) Payment shall be made immediately after completion of webcasting, phase wise, through account payee cheque or through RTGS, for which bidder shall submit the bank details along with their bid.
- c) The price quoted should be quoted in the supplied format.
- d) TDS and taxes shall be deducted at source, as per Government rules.
- e) Payment will be made to only lead/ prime bidder.

#### 5. Other Terms and conditions:

- a) Bidders are required to quote their rates based on estimated 100 to 200 polling booths. However, payment shall be made for actual number of orders placed.
- b) Bidder will deliver and Collect the tablet from the Store Section of the Daman District Election Offic (DEO's), from where it shall be distributed to booth level technical manpower <u>appointed/deployed</u> and authorized by DEO concerned. At this time, a detailed training will also be conducted by the Bidder to the technical manpower for smooth execution of live webcasting from their polling booth concerned. It will be the responsibility of booth level technical manpower selected by the concerning DEOs to receive and Deposit the Tablets from the polling parties safely. It shall also be responsibility of DEO to ensure that the equipment. like tablet, mounts.

charge, power units etc. is returned to the Bidder in working and undamaged condition. Loss and or damage of equipment shall be borne by the Office of District Election Officer, Collectorate, <a href="Daman">Daman</a> and may be recovered later from the person responsible for the loss and damage thereof, depending on the situation in each case,

- c) For viewing the live webcast in election, the secured username and password shall be provided by Bidder as required so that it can be seen in secured CUG.
- d) Bidder shall supply and install <u>46"</u> single panel LED <u>screens</u> at Officer of CEO, DEO and IGP, Daman for live viewing of webcast stream. This shall on rental basis.
- e) Bidder shall, in their bid offer, mention clearly the support required from the office of CEO, IGP and DEOs for web casting.
- f) Bidder shall submit technical compliance for each required product and services under seal and signature of OEM.
- g) Bidder should execute an agreement on non-judicial stamp paper of Rs. 100/- within a period of 7 day from the date of issuing the work order.
- h) Bidder should provide PIP (Project implementation plan) including the training schedule with a period of 10 day from issuing date of this work order.
- i) Tender Fee shall be in form of account payee Demand Draft / Bankers' cheque and EMD in form of Demand Draft / Bankers Cheque / Bank Guarantee, of any nationalized Bank, in favour of District Election Officer/ Collector, Daman payable at Daman.
- j) Late and delayed tender will not be considered. In case any unscheduled holiday occurs on prescribed closing / opening date the next working day shall be the prescribed date of closing / opening.
- k) TDS as applicable shall be deducted at source from the Bill.
- I) The Bidder shall supply the requisite Tablets and other hardware along with live streaming solution. Office of the District Election Officer will not purchase the tablets. The bidder will be paid overall rental and or service charges per location basis.

#### 6. Instruction to bidders

#### 6.1 Definitions:

Unless the context otherwise requires, the following terms whenever used in this RFP have the following meanings:

- a) "Bidder" means firm/company/organization who submits proposal, in association with their respective OEM(s), in response to this RFP (Request for proposal) document, for execution of work stated under Schedule A& B.
- b) "OEM" means Original Equipment Manufacturers or Technology providing company and part of the Bidder and or bidding company.
- c) "Committee" means committee constituted for evaluation of Proposals.
- d) "Company" means the firm/company/organization, selected through competitive tendering in pursuance of this RFP, for execution of work stated under Schedule A& B.

- e) "Contract" means the Contract entered into by the parties for providing implementation services along with the entire documentation specified in the REP.
- f) "ITB" means instruction to Company / Bidder.
- g) "IFP" means Invitation for Proposals.
- h) "Last Three Financial Years" means FY-2009-10, 2011-12, 2012-13
- i) "Proposals" means proposal submitted by Company / Bidder in response to the RFP issued by the office of District Election Officer/Collector, Daman.
- j) "Services" means the work to be performed by the Company / Bidder pursuant to this RFP and to the contract to be signed by the parties in pursuance of any specific assignment awarded by the office of District Election Officer/Collector, Daman.

#### 6.2 Conflict of Interest

The Company should provide professional, objective and impartial advice and at all times and hold the Client/Government's interests paramount, strictly avoid conflicts with other assignments/jobs or their own interests. The company shall not deploy former employees of the office of CEO,DEO and IGP, Daman in assignment under the RFP.

#### 6.3 Validity of Proposals

- a. Proposal shall remain valid for a period of 365 (three hundred and sixty five) days from the date of finalizing of Tender and or from the date of award of work order. Government reserves the right to reject a proposal valid for a shorter period as non-responsive.
- b. If required, the office of Chief Electoral Officer, Daman & Diu may solicit the Company's / Bidder's consent to extension of the validity period for a period not exceeding one year. The request and the response shall be made in writing. Extension of validity period by the Bidder / company will be unconditional and will not be permitted either to modify its commercial proposal upward and or downgrade offered technology on account of extension.

#### 6.4 Right to accept or Reject Proposal(s)

Officer of District Election Officer/Collector, .Daman reserves the right to annul the RFP process, or to accept or reject any or all the proposals in whole or part at any time, before the award of work order, without assigning any reasons and without incurring any liability to affected company(s) / bidder or any obligation to inform the affected company(s) of the grounds for such decision.

#### 6.5 Fraud and Corruption

- a) It is required that the Company /Bidder submitting proposal against this RFP must observe the highest standards of ethics during the process of selection of company and during the performance and execution of contract.
- b) For this purpose, definition of the terms are set forth as follows:
- c) Corrupt practice means the offering, giving, receiving or soliciting of anything of value to influence the action of government or its personal in contract executions.
- d) "Fraudulent practice" means a misrepresentation of facts, in order to influence a selection process or the execution of a contract, and includes collusive practice among Company (prior to or after Proposal submission).
- e) "Unfair trade practice" means supply of services different from what is ordered on, or change in the Scope of Work.
- f) "Coercive practice" means harming or threatening to harm, directly or indirectly, persons or their property to influence their participation in the selection process or execution of contract.
- g) Office of District Election Officer/Collector, Daman will reject a proposal for award, if it determines that the Company / Bidder recommended for award, has been determined to having been engaged in corrupt, fraudulent or unfair trade practices.

## 6.6 Clarification and Amendments of RFP

- a) During process of evaluation of the Proposals, the office of District Election Officer/Collector, Daman may at its discretion, ask Company / Bidder for clarifications on their proposal. The Company /bidder is required to respond within the prescribed time frame, failing which their bid proposal may be rejected.
- b) Officer of District Election Officer/Collector, Daman may for any reason, modify the RFP from time to time. The amendment(s) to the RFP would be clearly spelt out and the Company /Bidder may be asked to amend their proposal due to such amendments.
- c) Bidders are advised to check website of "Office of Chief Electoral Officer, UT of Daman & Diu" at <a href="https://www.ceodaman.nic.in">www.ceodaman.nic.in</a> regularly for any Addendum/Corrigendum/Amendments related to this Project.

## 6.7 Earnest Money Deposit (EMD)

- Any previous EMD lying with the office of District Election Officer/Collector, Daman in respect of Request for Proposal cannot be used for this RFP.
- b) The EMD will be forfeited on account of one or more of the following reasons:
- c) Company / Bidder withdraws its Proposal during the validity period as specified in the RFP.
- d) Company / Bidder does not respond to requests for clarification of its Proposal.
- e) Company / Bidder fails to provide required information during the evaluation process or is found to be non-responsive.
- f) In case of a successful Company / Bidder, the said Company / Bidder fails to sign the Agreement and / or provide the PBG in time specified in this RFP.

- g) The EMD of the successful bidder will be retuned after signing of contract and submission of Performance bank guarantee (PBG).
- h) EMD in respect of unsuccessful bidders will be refunded on final award of contract to the successful bidder.

#### 6.8 Penalty Clause:

- a) Vendor should ensure min. 2 hour of power backup in hardware (tablets) to be used for webcasting.
- b) Vendor will not be held responsible for any kind of power (after two hours)/internet= connection failure at any location and will not forfeit the charges of that booth.
- c) Due to any mistake of the person deputed at the polling booth of webcasting. Vendor will not be held accountable and it will not affect the payment due.
- d) If Vendor is not able to do the webcasting of any particular booth then Election Department will only forfeit the payment of maximum that particular polling booth only.

#### 6.9 Eligibility Criteria

- a. Sealed Bid shall be submitted following two bid system, namely Technical and financial, both sealed separately in two different envelopes should clearly have mention of Technical and Financial Bid, along with name of the Bidder, Tender number / name, date and time of opening. Both sealed technical and financial bid shall then be put in one another outer envelope, duly sealed, along with name of the Bidder, Tender number / name, date and time of opening. The Technical Bid shall contain EMD, duly signed and stamped tender document, relevant details as per the tender document, eligibility documents, without any price. The financial Bid shall contain only prices in the supplied format only.
