The terms & condition:-

- 1 The interested parties should quote their offer/ rates on letter-head under their signature & seal along with Tender form.
- 2 The rates should be inclusive of all taxes & valid up to 180 days. The Successful Tenderer shall have to bear all the costs of material spare parts/fitting/ labour/transportation etc.
- 3 The interested parties should have the above mentioned items ready in their stock for supply. The delivery of F O R is to be made at Govt. Horticulture Farm, Moti Daman. within 15 days, from the date of issue of date of supply Order.
- 4 The items to be supplied should have been produced/ manufactured, packed, labelled and being sold in conformity with the provisions of relevant Acts/ Rules in force. All the materials trailer/machinery/equipments/ spare parts, etc. to be used for the standard quality. If the materials of sub-standard quality are used
- 5 To examine the credentials, the random sampling of the items will be done in accordance with established norms. The items/ materials/ machinery/ equipments/ spare parts, etc. found defective or damaged or otherwise not conforming to the given specifications will be rejected and the supplier will be liable to replace the same within specified period of time in within 15 days.
- 6 The quantity to be supplied will be subject to replacement without prior notice.
- 7 The EMD, shall be furnished in the form of valid FDR or DD drawn in the name of **Chief Executive Officer, District Panchayat, Daman** and the same should be Enclosed with sealed tender. Tender received without enclosing specified EMD, if demanded, shall be rejected. EMD of the Successful Tenderer will be retained till 180 days. EMDs of the unsuccessful Tenderers will be released to them within 15 days from the date of opening of Tenders.
- 8 Interested parties should be registered with VAT Deptt. of the State / UT in which its HO/Sale office is located and should submit the copy of VAT Registration Certificate/TIN alongwith copy of PAN.
- 9 The interested parties should submit the copies of the Income Tax Returns filed by them for the last two Assessment years.
- 10 The payment will be made through direct RTGS/NEFT only after successful completion of supply to the satisfaction of the Chief Executive Officer, District Panchayat, Daman.
