
LIMITED TENDER NOTICE

Term & condition :-

1. The interested parties should quote their offer/ rates on letter-head under their signature & seal along with Tender form.
2. The rates should be inclusive all taxes with transporting etc. & valid up to 180 days from the date of opening of tender.
3. The interested parties should have the above mentioned items ready in their stock for supply. The delivery at F O R is to be made at Govt. Horticulture Farm, Moti Daman, Daman within 15 days, from the date of issue of supply Order.
4. The items to be supplied should be healthy and free for pest & diseases have been procured/ produced/ manufactured, packed, labelled and being sold in conformity with the provisions of Acts/ Rules in force.
5. To examine the credentials, the random sampling of the items will be done in accordance with established norms. The items found defective or damaged or otherwise not conforming to the given specifications will be rejected and the supplier will be liable to replace the same within specified period of time in within 7 days.
6. The quantity to be supplied shall subject to replacement without prior notice.
7. The EMD should be furnished in the form of Demand Draft drawn in the name of **Chief Executive Officer, District Panchayat, Daman** and the same should be enclosed with sealed tender documents. Tender received without enclosing specified EMD shall be summarily rejected. EMD of the Successful Tenderer will be retained till 30 days from 31st March, 2016. EMDs of the unsuccessful Tenderers will be released to them within 15 days from the date of opening of Tenders.
8. The interested parties should submit the copies of the Income Tax Returns filed by them for the last two Assessment years.
9. No Advance payment will be made until materials is received and will be paid on passing of bill.
10. The payment will be made only direct bank account /RTGS only after successful completion of supply to the satisfaction of the Chief Executive Officer, District Panchayat, Daman.
11. The Tender forms are available up to 04/ 11/2015 and may be obtained after payment of Rs.500/- in cash (Rs. Five Hundred only) Non refundable during working hours on any working day from Agriculture Section, District Panchayat, Dholar, Moti Daman, Daman.

The Tenders should reach this office up to 3.00 p.m. on 06 / 11/2015 in the sealed envelope super superscribed as "**Tender for supply of Horticulture plants**" the tender will be opened on the same day at 04:00 p.m. in presence of the Tenderers or their authorized representatives, if any, if possible.
