The Tender should send along with tender an Earnest Money Deposit equivalent to **3%** of the total tendered value in the form of deposit Receipt/Fixed Deposit Receipt drawn at State Bank of India or any other Scheduled Bank in favour of the Principal, Govt. Higher Secondary School, Bhimpore, Nani Daman.

The rate quoted by the tenderer(s) should be inclusive of transportation charges and all taxes for supply of food grains, Grocery, Break-fast & Vegetables items to the Ashramshala Hostel Bhimpore, Daman. As per the column in Sr. No. 1 sample of all items except items not Having specified brand should be sent along with the tender. Supply order will be issued monthly basis.

 - ii) A copy of VAT/CST Registration.
 - iii) A copy of PAN/TAN of income tax.
