1. The rate(s) quoted should be strictly for free delivery at F.O.R Government Hospital, Daman, and will be valid and operative for supply orders issued on or before <u>31/03/2016</u> from the date of invitation of tenders.

2. All Taxes/ Duties/ Royalties charges payable on sales/transport etc. within and / or outside the UT / State shall be payable by the supplier.

3. Where specification / mark/ manufacture are not specifying by this office, the rates should be quoted only for the first class and standard quality only.

4. The decision of the E- Tender Inviting Officer acceptance/rejection of any **Equipment for Measurement of Bone Mineral Density (Bone Densitometer)** supplied including the decision for equivalent specifications, standard and quality etc. shall be final.

5. (a) The successful tendered will have to pay within 10 days from the date of demand, an amount equal to 10% of the total value of articles (b) Non-receipt of Security Deposit within stipulated time limit will result in automatic cancellation of the order for supply without any intimation.

25.
