

- 1 The interested parties should quote their offer/ rates on letter-head under their signature & seal.
- 2 The rates should be inclusive of all taxes & valid up to 180 days.
- 3 The Rates for machinery should be inclusive all taxes & quoted for FOR at Govt. Horticulture Farm, Moti Daman.
- 4 The Rate should be quoted by the firms who are able to supply the equipment immediately within 10 days from receipt of the clear order from this office.
- 5 The items to be supplied should have been produced/ manufactured, packed, labelled and being sold in conformity with the provisions of relevant Acts/ Rules in force.
- 6 The supplies which found to be defective or in damage condition or otherwise not conforming to the given specifications will be rejected. The supplier has to replace the same within specified period of time.
- 7 The quantity to be supplied will be subject to replacement without prior notice.
- 8 The EMD, shall be furnished in the form of valid FDR or DD drawn in the name of **Chief Executive Officer, District Panchayat, Daman** and the same should be Enclosed with sealed tender. Tender received without enclosing specified EMD, if demanded, shall be rejected. EMD of the Successful Tendere will be retained till 180 days. EMDs of the unsuccessful Tenderers will be released to them within 15 days from the date of opening of Tenders.
- 9 Interested parties should be registered with VAT Deptt. of the State / UT in which its HO/Sale office is located and should submit the copy of VAT Registration Certificate .
- 10 The interested parties should submit the copies of the Income Tax Returns filed by them for the last two Assessment years along with copy of PAN.
- 11 The payment will be made through RTGS/ direct bank accounts only after successful completion of supply to the satisfaction Chief Executive Officer, District panchayat, Daman .
- 12 The tender forms are available up to 04 /08/2016 and may be obtained after payment of Rs.500/- (Rs. Five Hundred only in cash non refundable) during working hours on any working day from Agriculture Section, District Panchayat, Dholar, Moti Daman, Daman.
