

03. The bidder shall have to produce a copy invoice for purchase of clothings of [particular brands from the company or authorized distributor/dealer along with the materials.
04. The size and measurement of uniform kit articles items and sample for the same can be had from Fire & Emergency Services, Somnath, Nani Daman.
05. The tenderer will have to be produce sample of the items quoted along with tender. Tenders received without sample will be summarily rejected.
06. The rate tendered should be strictly for free delivery at Fire & Emergency Services, Somnath, Nani Daman.
