1. The Tenderer should quote their rates on their own letter pad OR on plain paper with their rubber stamp. Rate should be quoted against work and should be inclusive of all taxes.

3. The successful tenders has to furnish Security Deposit of an amount equal to 5% of cost put to tender.
4. The work should be completed within 15 days from the date of work order. The work should conform to the given specifications.
5. The payment will be made after completion of work and at the satisfaction of this Department.
6. Income Tax will be deducted as per the I.T. Rules. Labour cess will also be deducted as per rules.

The sealed tender should reach this office up to **4.00 P.M** on **04/07/2016** in sealed envelope super scribed as "Tenders for "**Enriching existing Forest Plantation by Sowing of Hoka Seeds etc**" and it will be opened on the same day, if possible, in presence of bidders or their representatives, if present.
