

**TERMS & CONDITIONS :-**

1. The Public auction of Condemnation of Vehicles bearing Registration No.DD 03-J-0019 Chevrolet Tavera pertaining to the Office of the Assistant Engineer, P.W.D., Sub Div. No.II, Nani Daman shall be carried out under the supervision of the committee consisting of the Executive Engineer, PWD, Daman, the Assistant Engineer, PWD, SD-IV, Daman & Divisional Accountant, P.W.D., WD-I, Daman on 30/07/2016 at 11.00 AM.
2. The interested bidder shall have to deposit a token amount of ₹.8,000/- at the time of auction for taking part in it. The said amount shall be refunded back to the unsuccessful bidder after the auction. The successful bidder has to deposit 10% of the offered bid on the spot.
3. The bidder should offer bid for a minimum of ₹.1,000/- (Rupees One Thousand only) above the upset price of Vehicle.
4. An offer shall be considered as highest and final only if the amount of bid offered by the bidder is announced consequently three times uninterrupted.
