- The upset price for the bid is Rs.1,34,543/-(Rupees One Lakh Thirty Four Thousand Five Hundred Forty Three Only) the intended Tenders are required to bid above the upset price.
- The tenders shall be given on as per tender from and submitted in the name of Chief Executive Officer, District Panchayat, Daman in a sealed cover super scribed as "Tenders for sale of Mango Fruit."
