13. The interested parties should quote their offer/ rates on their letter head or plain paper with their signature & seal. Prior making an offer, the interested parties are advised to inspect the Open Well.
14. The interested parties should have experience in the field of Fabrication work.
15. The offered rates should be inclusive all taxes & valid up to 31st March, 2017.
16. The work includes M.S.I Beam, M.S. Angel, M.S.Patti, G.I.Fencing Jali, etc.
17. All the materials used for the work should be of standard quality. If the material of sub-standard quality is used, the same will be rejected and the Successful Tenderer shall have to replace the same within specified period of time.
18. The interested parties, along with their Tender, must enclose an EMD as described above, in the form of valid FD/ DD drawn in the name of Zonal Agriculture Officer, Daman. The Tender received without the prescribed EMD shall be rejected. The EMDs of the unsuccessful Tenderer will be returned to them within 30 days from opening of the Tenders. The EMD of the Successful Tenderer will be retained by the Department till sixty days from the date of conclusion of the period of contract.

If the Successful Tenderer fails to fulfil his obligations as per terms and conditions of the Tender Notice and Work Order issued thereupon, his EMD, Security Deposit & Performance Guarantee shall be forfeited to the Government. The Department shall also have the privilege to use all such ways & means to protect the interest of the Government.
20. The payment will be made on successful completion of works and to the satisfaction of this office.
21. Applicable taxes, if any, will be deducted from the final bill of the Successful Tenderer as per the I.T. Rule.
22. The tenders should reach this office up to 12.00 A.M. on 07/03/2017 in the sealed envelope super scribed as "Tender for Providing and Fixing Fencing for Farm Open Well" at Govt. Seed Multiplication Farm, Kachigam, Nani Daman and will be opened on the same day at 04:00 P.M. in presence of the Tenderers or their authorized representatives, if any possible.
