
AUCTION NOTICE

Terms and conditions:-

- 1) This auction is on the condition "as is and where is" basis.
- 2) The Starting Bid Amount will be "Upset Price" of the Items.
- 3) The auction shall be held on bid system. Interested bidder shall have to deposit a token amount of ₹ 1,000/- at the time of auction for taking part in it. The said amount shall be refunded back to the unsuccessful bidder after the auction.
- 4) An offer shall be considered as highest and final only if the amount of bid offered by the bidder is announced consequently three times uninterrupted.
- 5) The successful bidder shall have to deposit an amount equal to 50% of the highest bid offered as Security Deposit on the spot. Further he has to deposit balance amount within three days from the date of issue of letter accepting highest bid at his own cost. This department shall not be responsible for any loss/damage of the items if successful bidder fails to lift the items within stipulated time.
