All the agencies are hereby directed to scan their tender fees and E.M.D in form of FDR valid for 6 month or more than that. It is mandatory to submit tender fee and EMD online failing which the price bid of that agency will not be opened online. Physical submission of such scanned documents shall reach to office of the Dy. Conservator of Forest, Daman. within 3 (three) working days after closing of online bidding and also for any electrical works copy of electrical license should be attached in addition to other requirement for bidding. The agency should confirm and certify that the document scanned online i.e. Tender fees and EMD) are also physically submitted in the sealed cover. If physical document is not found in sealed cover then necessary action will be initiated against the concerned agencies for debarring him/her for the period of three years in the U.T. of Daman Diu and Dadra and Nagar Haveli.

Experience Certificate from the Executive Engineer/Municipal Engineer/Forest Department of satisfactory completion of **similar** types of Govt. work i.e. one work of 80% estimated cost OR two work of 60% estimated cost OR three works of 40% estimated cost put to tender. Registration as approved contractor, Service Tax Registration VAT/G.S.T. Registration from local VAT Dept (Lowest bidder must obtain local VAT/G.S.T. Registration within 15 days). Pan Card.
