

TERMS AND CONDITIONS FOR BROADBAND INTERNET CONNECTIVITY AT THE SPEED OF 4 MBPS (UNLIMITED USAGE) FOR THE POLICE DEPARTMENT, DAMAN FOR THE YEAR 2017-18.

1. Upload speed shall not be less than 2 MBPS in any case at anytime and download speed shall not be less than 3 MBPS in any case and anytime.
2. Tenderer shall ensure internet connectivity on 24 X7 basis, as surveillance of CCTV camera are to be done.
3. The rate(s) quoted shall imply free delivery and installation of the equipment at the location mentioned in the schedule including Transportation, loading/unloading etc. The rate will be valid and operative for one year from the date of issue of work order.
4. The rate should be quoted inclusive of all taxes and F.O.R. at our Daman Police Head Quarters only.
5. The (CMSPs/UASLs/Internet Service Providers/ISPs) of category A or B must have GST registrations and should be attached with quotation documents.
6. The bid shall consist of all documents / papers mentioned in the tender document. The bid(s) so received from the bidder will be opened by the committee
7. The **Earnest Money Deposit** for an amount of **₹.2,500/-** (Rupees Two Thousand Five Hundred Only) in form of Account Payee Demand Draft, Fixed Deposit Receipt, Banker's Cheque or Bank Guarantee from any of the Banks drawn in favour of the "DIGP DD, Daman". **Quotation without EMD will not be considered and quotation will be summarily rejected.**
8. The rates should be quoted only for the items specified in the schedule of requirements and should be for the items or given specifications confirm to the standard (s) requirements of the given specification/mark/manufactures.
9. Rates quoted for items other than the required specification/mark/manufacture may not be considered. However indigenous manufacture (s) may quote their own makes provided.
10. Where specifications/mark/ manufacture is not specified by this office the rates should be quoted only for the 1st Class and standard quality.
11. The successful bidder shall have to pay Security Deposit of an amount equal to 10% of the total value of the articles within ten (10) days from the date of demand, failing which the supply order placed to the CMSPs/UASLs/Internet Service Providers/ISPs) for supply of internet connectivity will stand automatically cancelled without any intimation. The Performance Security Deposit can be accepted from any Nationalized Bank payable at Daman. The validity of the FDR shall be for a minimum of six months.
12. The successful bidder has to give service and repair of Internet connectivity within 03 hours time limit.
13. If the material supplied not found as per the specification, the entire supply order liable for cancellation and E.M.D./Security Deposit paid will be forfeited to Government and said agency shall be blacklisted.

14. The E.M.D/Security Deposit paid will be refunded only on satisfactory completion of the work order/s.
15. No advance payment or part payment will be made. Payment will be made only after completion of work as per order given.
16. No extra charges for Installation, equipments, router, cable, cabling, packing, forwarding or insurance etc. will be paid over the rates quoted.
17. In case of failure to provide services, as per conditions and within stipulated time, the same will be procured if required, from the bidder who offered next lowest or from any other sources as may be decided by the Quotation Inviting Authority and the loss to Government on account of such purchase (s) shall be recovered from the original supplier's from E.M.D./ Security Deposit or bills payable. **The supplier shall have no right to dispute with such procedure.**
18. If at any time, after the supply order placed to the CMSPs/UASLs/Internet Service Providers/ISPs to provide services of Internet connectivity, for any reason whatsoever not required, in whole, or part, of the quantity thereof, as specified in the supply order, the Quotation Inviting Authority shall give notice in writing to supplier for such curtailment and in such case, the supplier shall have no claim for compensation by reason of any alteration which shall involve any curtailment or the supply originally contemplated.
19. The E.M.D. / Security Deposit paid by the bidder(s) earlier against any other quotation(s) or supply is/are not adjustable with E.M.D./Security Deposit required for this work/quotation.
20. If the supplier, whose quotation is accepted, fails to execute the work order within the stipulated time, the E.M.D./Security Deposit of such bidder will stand forfeited to the Government and the contract for the supply shall stand terminated with no further liabilities on either part to the contract.
21. If any dispute arises, the case shall be decided within the jurisdiction of Daman District.
22. Right to accept or reject without assigning any reason, thereof, any or all quotation in part or in whole is reserved with the Quotation Inviting Authority and his decision(s) or all matters relating to acceptance or rejection of the quotations as a whole or in part will be final and binding to all.
