**** Terms and Conditions for Purchase of Grass Cutter Machine for maintenance of Swami Vivekananda Sports Complex, Nani Daman.**

E-tender (online) is hereby invited from the reputed Manufacturers / Authorized Dealers / Distributors by the Sports Department, Daman for **“Purchase of Grass Cutter for maintenance of Swami Vivekananda Sports Complex, Nani Daman”** as per Schedule – B attached at Sports Department, Daman, for the reputed brands and companies providing Equipments/Machinery of **“International Standard/BCCI Approved”** for the purpose of maintenance of the Swami Vivekananda Sports Complex with the following conditions:

1. E-Tender (Two bid system) are invited from the Manufacturers / Authorized Dealers / Distributors of the specified Equipments/Machinery (documentary evidence should be submitted with the technical bids.) for the financial year 2017-18.
2. Hard copy of the technical bid should be in a sealed envelope subscribed as **“Purchase of Grass Cutter for maintenance of Swami Vivekananda Sports Complex, Nani Daman”** and addressed to the Office of the Head of Sports, Sports Department, Near Football Ground, Moti Daman – 396 220.
3. The Tender documents & other details will be available on <https://www.nprocure.com> upto **28/11/2017**. Tender notice can also be seen at web site www.daman.nic.in
4. The Manufacturers/Authorized Dealers/Distributors of the specified Equipments/Machinery should be in the trade for the last three years and documentary evidence should be enclosed with the technical bid.
5. The rate (s) quoted by bidder shall be inclusive of all taxes & charges and free delivery to be made at Daman. No extra charge for packaging, forwarding and insurance, transportation etc. will be paid.
6. The tenderer should specify the name of the manufacturer/company for the items quoted by him along with catalogue of the items. A detailed catalogue with drawing indicating specifications, description etc. also be submitted in the hard copy envelope.

7. Only GST will be paid on the items on which it is chargeable under the GST Act or the Rules made there under.
8. Copy of the GST Registration should be attached with tender document.
9. The bidder should submit the proof of annual turnover of Rs. 25,00,000/- and above per annum for the specific equipments/machinery only including export for the last three (03) years. The tender received without or below annual turnover of Rs. 25,00,000/- shall not be accepted.
10. The rate(s) should be quoted only for the items specified in the list of requirement and should be for the items of given special manufacture/dealer.
11. The rate accepted shall be operative for a period of one (01) year from the date of the acceptance of rate. The bidder whose rates are approved, will be bound to supply the Equipments/Machinery on approved rate for a period of one year.
12. Rate(s) quoted for items other than the required specification/make/manufacture may not be considered.
13. The Sports Department, Daman will be at liberty to accept the tender for the entire quantity or the part thereof at the rates submitted by the bidder or at reduced rate during the negotiations if any.
14. The quantities mentioned in the tender form are only tentative and may vary for which the bidder will not be entitled to any compensation whatsoever.
15. The successful bidder shall comply with the order within the stipulated period for delivery. The quantities may be increased or decreased as per the requirement at the time of placing order.
16. It must be noted that this is just an enquiry and does not amount to any commitment on the part of Sports Department, Daman to order any or all products offered. The decision of Sports Department, Daman in this regard would be final and be entirely, at its discretion.
17. The Technical Bid of the bidders will be opened first and the Financial Bid will be opened only of the bidders whose technical bid is accepted/qualified.
18. Where Specification/Make/Manufacture/Dealer is not specified by this office, the rate(s) should be quoted only for the superior quality **(International Standard/BCCI Approved)**.
19. Equipments/Machinery supplied by the successful tenderer shall be randomly checked & verified by the Tender inviting Officer through Departmental staff/authorized staff. Acceptance Equipments/Machinery shall be strictly subject to satisfaction of the verifying authority. The

Equipments/Machinery which are not found as per specification given in the tender will be directly rejected and the same has to be replaced by the cost of the tenderer.

20. Supplier shall provide hand holding training to the department at the time of delivery of machine. Supplier shall provide on site warranty and service for 01 year free of cost. After one year supplier shall provide service/repair on call/request as and when required by the department.
21. Payment shall be released only after acceptance of Equipments/Machinery and verification by the authority. Any condition relating to advance payment of the ordered material will not be entertained.
22. The duly filled authorization letter for release of payment through RTGS must be submitted along with the technical bid envelope.
23. The Earnest Money Deposit (E.M.D) of **`.15,000.00** is payable with the tender in form of Demand Draft issued by the **Scheduled Bank** in favour of **Head of Sports, Daman**. Tender received without EMD will be treated as invalid.
24. The amount of Earnest Money Deposit paid by the Tenderer(s) whose tenders are not accepted will be refunded to them within 15 days.
25. The Successful tenderer shall have to deposit 5% of Tender amount as security deposit through Demand Draft or in the form of Bank Guarantee of Nationalized Bank and shall have to sign a contract with Head of Sports as per rules within 15 days after receipt of order. The EMD paid by the successful tenderer will be adjusted towards Security Deposit. No interest will be paid on the amount of the security deposit money.
26. The tenderer has to sign at the bottom of the each and every page of the hard copy with the rubber stamp and date.
27. The evaluation will be made at all inclusive total price of a bid. The total price means the total for the Equipments/Machinery mentioned in **Schedule - B**.
28. In case of successful tenderer, who decline to accept the contract order, the EMD will be forfeited and the concerned agency will be blacklisted.
29. Delayed tenders, post tenders offers received after closing of tenders will summarily be rejected. No responsibility will be accepted for delays in postal transit.
30. Bidder shall have to submit the name of Bank, Name of branch with the address, A/c No. and MICR No., IFSC Code.
31. The items specified in the Schedule - B should be supplied at the site i.e. Office of the Head of Sports, Sports Department, Near Football Ground, Moti Daman (UT) 396 220.

- 32.** All bills should be in DUPLICATE and should invariable mention the number and date of supply order.
- 33.** All bills for amount above `5,000/- should be pre-receipted on a Revenue Stamp of proper value. Bills for amount exceeding `5,000/- not pre-receipted on Revenue Stamp of proper value will not accepted for payment.
- 34.** Each bill in which GST is charged must contain the following certificate on the body of the bill.
“CERTIFICATE that the Equipments/Machinery on which GST has been charged have not been exempted under the GST Act or the Rules made there under and the amount charged on account of GST on these Equipments/Machinery is not more than what is payable under the provisions of relevant Act or Rules made there under.”
- 35.** In respect of any dispute given rise to the legal proceedings between the parties, the courts at Daman shall alone have the Jurisdiction.
