- 1.4 Attached is the prescribed format of qualifying details. Interested, parties may use this format & add additional information as part of annexure, if they wish to.

- 1.6 Applications without required information or enclosures are liable to be rejected.
- 1.7 The project is to be executed for Three year in which bidders will have all the rights to develop, manage and operate the area to earn revenue prior approval from the competent authority.

# SCOPE OF WORK:

- The purpose of the work is to generate revenue for the UT Administration of Daman and Diu. Bidders are requested to check the feasibility of the locations at their own. And the no of selected locations shall be finalized only after approval from The Deputy Director Tourism, Daman
- All the work will have to be done as per specifications and under supervision of the Tourism Department Daman. Bidders have to submit the concept drawing and 3-D views whenever asked for the same. Bidders would also require making necessary revisions as suggested by the Tourism Department Daman in the drawings or 3-D view.
- All the project will be executed at bidders own cost and bidders will be given the Advertisement rights for the revenue generations with the prior approval by the Tourism Department, Daman.
- The sequence of installation shall be decided in consultation with the Tourism Department, Daman. The Bidder shall prepare the detailed program of work in Bar Chart form and get the approval from the Tourism Department before start of work.
- The land will be provided for advertisement shall be at free of cost for the period of Three years.
- All the permission to be taken is in bidders' scope and all the expenditure for getting permissions is also in bidders' scope.
- The purpose of the work is to come up with revenue sharing model with respect to auctioned prime location advertisement space which may cater following requirements of administration of Daman and Diu.
- Private party will be given advertisement rights for revenue generation.
- The UT Administration of Daman and Diu may ask private party to share advertisement space for its own policies and programme.
- Number of advertisement in this regard will have a monthly Upper limit in terms of nos of days, nos of advertisements and nos of locations.
- The bidder has to design and develop these advertisement, bill boards, digital boards according to needs of administration by its own. This will also include the creative part involved in designing advertisements.
- The Bidder will also pay a fixed monthly rent to Tourism Department for using prime locations for display of advertisements.
- Bidders are requested to check the feasibility of the locations at their own. This
  number of locations is subject to variation and decision of the Tourism Department,
  Daman is final in this regards.

- Bidders have to come up with a plan which is beneficial for both the stockholders
  i.e. bidder and the UT Administration of Daman and Diu.
- The installation of the display boards, bill boards or any other advertisements will be designed in such a way that it will not be damaged due to natural calamities.
- Structural Stability Report should be produced before installation of the advertisement by the government authorized structural engineer.
- If any damage occurs by your any advertisement medium, the entire cost, penalty, court case will be applicable by the bidder not by the Tourism Department.
