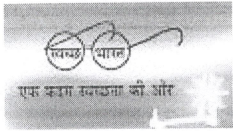

2. The interested bidder shall have to deposit a token amount of ₹.5,000/- at the time of auction for taking part in it. The said amount shall be refunded back to the unsuccessful bidder after the auction. The successful bidder has to deposit 10% of the offered bid on the spot.
3. An offer shall be considered as highest and final only if the amount of bid offered by the bidder is announced consequently three times uninterrupted.
4. **The auction value shall be selected on the basis of item wise offer by highest bidder.**
5.
