1. Minimum Eligibility Criteria:

- I. Only one bid per bidder is permitted.
- II. No Joint venture/Consortium permitted for bidding.

2. Minimum Qualification Criteria:

Turn Over: To qualify for award of the contract, each bidder should have achieved an average annual **financial turnover on construction works of at least 50%** of the estimated cost during the immediate last 3 consecutive financial years ending 31st March 2018.

3. (i) Experience of Similar Works:

The Bidder should have satisfactorily completed similar works during last 7 (Seven) years on the last day of the month previous to the one in which the tenders are invited.

- a) Three similar works costing equal to 40% of the estimated cost. **OR**
- b) Two similar works costing equal to 60% of the estimated cost. **OR**

c) One similar works costing equal to 80% of the estimated cost.

Similar work means “Interior works OR Electrification& HVAC, Fire fighting, Sound Reinforcement System, False ceiling and Wall paneling with Acoustical treatment for Auditorium/Building/Cinema Halls.

The value of executed work shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to previous day of last date of submission of tender.

(ii) **MOU:** The bidder has to submit MOU with specialized agency/contractor who has executed the work of HVAC on a ₹100 Stamp paper during the time of submission of bid. In addition, the bidder have to submit the experience certificate of the HVAC contractor who has completed similar works during last 7 (Seven) years ending previous day of last date of submission of tender. Three similar works costing equal to ₹ 65.00 Lakhs of the estimated cost **OR** Two similar works costing equal to ₹ 98.00 Lakhs of the estimated cost **OR** One similar works costing equal to ₹ 130.00 Lakhs.

4. Bidder should not have incurred any loss (profit after tax should be positive) in more than two years during the last five consecutive balance sheets, duly certified and audited by the Chartered Accountant.
 - 1) Solvency of the amount equal to 40% of the estimated cost of the work is required to be provided by the bidder.
 - 2) If any clarifications are required, regarding the bidding document the same can be obtained from the Executive Engineer, OI DC Daman, on any working day or during pre-bid, in written.
 - 3) Other details can be seen in the bidding documents.
 - 4) All necessary documents shall be submitted online and in hard copy. It is compulsory to submit the original Tender fee in the form of DD and EMD in the form of FDR & Bank Guarantee in online and hard copy.
 - 5) Conditional bid will not be accepted.
 - 6) The intending bidder must read the terms and conditions of **CPWD-6** carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
5. The Bidder should have a valid “AA” Class registration issued by CPWD/State PWD/MES /RAILWAYS. Non submission of a valid registration shall make the bid non responsive and the bid shall be rejected.
6. The Financial Bid should be submitted online only. The submission of financial bid in hard copy shall make the bid non-responsive and the bid shall be rejected.

OI DC reserves the right to reject any or all tenders without assigning any reason and the selection shall be at the absolute discretion of the Corporation and Corporation’s decision in this respect shall be final and binding.
