Terms & Conditions for Supply of Nutritious Food Grain / Grocery Items, Vegetable, Fruit etc.

- 1. The tenderer will have to submit Physical Nutritious Food Grain / Grocery Items, Vegetable, Fruit etc. samples as per the specification along with the Tender Fee & EMD in original on or before 03/12/2018, 10.30 am
- 2. Samples of <u>all items should</u> <u>be attached</u> with tender in quantity of 500 grams. (for food grains items). Oil should be in quantity of 5ltr tin, 100gms for spices and one number/packet of each for other items.
- 3. Oil, Salt, Wheat Flour should be compulsorily in fortified. Polythene cans, empty cans be collected by supplier from Zari Ashram Shala, Moti Daman as & when the cans are empty.
- 4. The bidder should quote the rates for all items (food grains, Grocery, vegetable, fruits, egg, etc) and samples for the same are also compulsory.
- 5. The bidder shall carefully examine the terms, conditions and specifications of the tender notice enclosed. And in case of any doubt the tenderer shall get it clarified with the Office of Head Master, Govt. Sarvottam Higher Sec. School, Zari, Moti Daman.
- 6. In First instance, the Physical Verification of "Nutritious Food Grain / Grocery Items, Break Fast, Vegetable, Fruit etc. Food SAMPLES", Technical Bid of all the bidders & if, it's found to be satisfactory there after the Financial Bids of the eligible bidders/Tenders only will be considered for the said Tender.
- 7. The collection of the Physical Samples of the non selected tenderer shall be made within 20 days from the opening of the Financial Bid from this Office And there will be no responsibility of this Office after 20 days regarding miss-placement, breakage, theft etc.
- 8. Physical sample of the successful bidder will be considered within the supply order.
- 9. Tenders received after due date and time mentioned above will not be accepted.
- 10. The Head Master, Govt. Sarvottam Higher Sec. School, Zari, Daman reserves the rights to accept or reject any tender without assigning any reason.
- 11. Tender incomplete in any respect or conditional Tender will not be accepted.
- 12. Tender Fee of Rs. 500 (Rupees Five Hundred only) (Non refundable) in form of Demand Draft (DD) from any Nationalized / Scheduled Bank in favor of 'Head Master, Govt. Higher Secondary School, Zari, Moti Daman' and should be kept in a sealed separate cover super-scribing Tender Fee. Tender received without "Tender Fee" will directly disqualify for the said Bidding / Tender.
- 13. The Earnest Money Deposit (E.M.D.) of Rs. 13,326/- (Rupees Thirteen Thousand Three Hundred Twenty six only) in form of Fixed Deposit Receipt (FDR) from any Nationalized / Scheduled Bank drawn in favor of 'Head Master, Govt. Higher Secondary School, Zari, Daman' and should be kept in a sealed separate cover superscribing E.M.D. without mentioning amount. Tender received without E.M.D. will directly disqualify for the said Bidding / Tender.
- 14. The submission of E.M.D. is compulsory for all the tenders and no exemption will be granted for submission of E.M.D. in any case.

- 15. Bid securities of the unsuccessful bidders will be returned after expiry of the final bid validity on or before the 30th days after award of the contract.
- 16. Bid securities of the successful bidder fixed deposit receipt will remain valid for a period of sixty days beyond the date of completion of all contractual of the supplier.
- 17. The Head of Office will consider extension of time for remitting the Security Deposit as demanded. However, in case of detail to consider such extension, the supplier is bound to abide by the limit given and liable to make good any loss to the Government on account of his failure to abide by the time limit stipulated.
- 18. The goods shall be nicely packed (without using stapling pins) in totally transparent polypropylene bags as per quantity to be delivered at Zari A/S, Daman and all quantities to be delivered to Zari A/S, Daman shall be properly packed together in a cardboard cartoon and presented in the Head Master, GSHSS, Zari, Daman for verification of quality & quantity then shall be delivered by the successful tenders to Zari A/S, Daman under Supervision of the Head Master, GSHSS, Zari, Daman representative. The supply shall have to be made latest by 5th of every month without fail to Zari A/S, Daman located in Nani Daman.
- 19. In case of failure to replace the non-accepted and rejected articles from supplies made as mentioned in the conditions, the loss undergone by the Government will be recovered from the supplier's Security Deposit / Earnest Money or payment due of any bill(s) to the extent required.
- 20. In case of failure to supply the stores(i. e. Nutritious Food / Grocery Items, Vegetable, Fruit etc.) ordered for as per the conditions and within the stipulated time, the same articles will be obtained, if required from the tenders who offered next higher rates or from any other sources, as may be decided by the Tender Inviting Officer and the loss to the Government on account of such purchase(s) shall be recovered from the supplier's Security Deposit/Earnest Money or bills payable. The suppliers shall have no right to dispute with such procedure.
- 23 If at any time after the order for supply of Stores, food grains, vegetables, fruits, etc the Tender Inviting Officer shall for any reason whatsoever not require the whole or part of the quantity thereof as specified in the order. The Tender Inviting Officer shall give notice in writing of the fact to the supplier(s) who shall have no claim to any payment of compensation whatsoever on account of any profit or advantage which the supplier(s) might have derived from the supply of articles in full, but which did not derive in consequence of the full quantity of articles not having been purchased, nor shall have any claim for compensation by reasons of any alterations having been made in the original instructions which shall involve any curtailment of the supply originally contemplated.
- 24 The Earnest Money / Security Deposit(s) paid by the tender(s) earlier against any tender(s) or supply order(s) is are not adjustable with Earnest Money or Security Deposit required by these conditions.
- 25 All bills should be in DUPLICATE and should invariably mention the number and date of supply order.
- 26 All bills for amount of above Rs. 5,000/- should be pre-receipted on a Revenue Stamp of proper value. Bills for amount above Rs. 5,000/- which are not pre-receipted on Revenue Stamp of proper value will not be accepted for payment.
- 27 Each bill in which GST is charged must contain the following certificate on the body of the bill.
 - "Certified that the goods on which GST has been charged have not been exempted under the Central GST Act or the Rules made there under and the amount charged on account of GST on these goods is not more than what is payable under the provisions of relevant Act or the Rules made there under".
- 28 The rate should be F.O.R. concerned Zari A/S, Daman and should include excise duty, sales tax, Freight charges, any other taxes rates of imposition whatever liable in respect of the supplies. The Head Master, Zari A/S, Daman shall not be liable to pay any tax, freight etc. which has been expressly stipulated in the tender in the event of

- acceptance of the tender. Suppliers are bound to pay tax to the Govt. at their own level
- 29 On acceptance of the tender it will become a contract and shall be bound by the terms and conditions of the tender under the provisions of GFR.
- 30 The Performance Security amount shall stand forfeited in case of breach of any of the conditions mentioned herein and if the services of the contractor are found unsatisfactory.
- 31 The Tendering firms / agencies are required to submit following documents compulsorily.
 - i. Copy of Food Safety and Standards Authority License of the State/U.T. Govt. of the particular items/head for which tender is applied. The same should be valid till 31/03/2019. (Except Vegetable & Fruit Supplier)
 - ii. Copy of PAN Card.
 - iii. Copy of GSTIN Number Undertaking of Exemption from GSTIN.
 - iv. Copy of Income Tax Returns for last two years (i.e. Assessments years 2016-17& 2017-18 OR 2018-19).
 - v. Earnest Money Deposit (E.M.D.) of Rs.13,326/- (Rupees Thirteen Thousand Three Hundred Twenty Six only) by drawing a FDR on any Nationalist Schedule Bank, in favour of 'Head Master, Govt. Higher Secondary School, Zari, Daman'
 - vi. Declaration of Non black listed by the vendor
- 32 Tender Fee of Rs. 500/- (One Hundred only) (Non refundable) in form of DemandDraft (DD)from any Nationalized/Scheduled Bank in favour of **Head Master**, **Govt. Higher Secondary School**, **Zari**, **Daman**'
 - i. Copy of Terms and Condition duly signed by the firms/agencies with firm seal.
