TERMS AND CONDITIONS FOR INSTALLATION, COMMISSIONING DEDICATED LEASE LINE INTERNET CONNECTIVITY, AT THE SPEED OF 25MBPS AND 10MBPS AT 02 LOCATIONS OF DAMAN FOR USE IN DAMAN & DIU POLICE

1. Upload and download speed shall not be less than 25 MBPS and 10 MBPS at PHQ and SP/Office respectively and vendor shall provide a SLA accordingly.
2. If at any time, the upload and download speed go down from @25MBPS and @10MBPS at PHQ and SP/Office, respectively, vendor shall be liable for penalty to be calculated as per diem basis.
3. Tenderer shall ensure internet connectivity on 24 X7 bases, for smooth running of e-Office application and other software of the department.
4. The rate(s) quoted shall imply free delivery and installation of the equipment at the locations mentioned in the schedule including Transportation, loading/unloading, installation, testing, troubleshooting etc.
5. The rate will be valid and operative for one year from the date of issue of work order.
6. The rate should be quoted inclusive of all taxes and F.O.R. at our Daman Police Head Quarters only.
7. The (CMSPs/UASLs/Internet Service Providers/ISPs) of category A or B or C must have GST registrations and should be attached with Tender documents.
8. The bid shall consist of all documents / papers mentioned in the tender document. The bid(s) so received from the bidder will be opened by the committee.
9. The Earnest Money Deposit for an amount of ₹.5000/- (Rupees Five Thousand Only) in form of Account Payee Demand Draft, Fixed Deposit Receipt, Banker's Cheque or Bank Guarantee from any of the drawn in favour of the "DIGP DD & DNH, Daman". Tender without EMD will not be considered and Tender will be summarily rejected.
10. Where specifications/mark/ manufacture is not specified by this office the rates should be quoted only for the 1st Class and standard quality.
11. The successful bidder shall have to pay Security Deposit of an amount equal to 10% of the total value of the work within ten (10) days from the date of demand, failing which the supply order placed to the CMSPs/UASLs/Internet Service Providers/ISPs) will stand automatically cancelled without any intimation. The Performance Security Deposit can be accepted from any Nationalized Bank payable at Daman. The validity of the FDR shall be for a minimum of six months.
12. The E.M.D/Security Deposit paid will be refunded only on satisfactory completion of the work order/s.



13. No advance payment or part payment will be made. Payment will be made only after availing of the service.
14. No extra charges for Installation, equipments, router, cable, cabling, packing, forwarding or insurance etc. will be paid over the rates quoted.

In case of failure to provide services, as per conditions and within stipulated time, the same will be procured if required, from the bidder who offered next lowest or from any other sources as may be decided by the Tender Inviting Authority and the loss to Government on account of such purchase (s) shall be recovered from the L1 Bidder. The supplier shall have no right to dispute with such procedure.
16. Commissioning certificate shall be issued after testing at both locations indicating the speed / bandwidth achieved.
17. The E.M.D. / Security Deposit paid by the bidder(s) earlier against any other Tender(s) or supply is/are not adjustable with E.M.D./Security Deposit required for this work/Tender.
