



- 2) The supplier shall submit **EMD** of an amount of **Rs. 2,500/-** in the form of FDR of any nationalized Bank (SBI, Moti Daman) in favour of Chief Town Planner/Associate Town Planner, Daman. Quotation without EMD shall not be considered and rejected.
- 3) In case successful supplier fails to supply the items as per the specification, the EMD amount shall be forfeited. After successful supply and commencing of the items, the said EMD amount shall be treated as security deposit towards guarantee for good performance/working of the system which shall be released only after six months.
- 4) The rates for the above items should be inclusive all taxes & quoted for at , Daman.
