- 6 The Bidder is himself responsible for supply of Seeds through vehicle etc. including obtaining vehicle permission etc. from the competent authority during the period of Lockdown.
- The EMD of ₹.12,500/- should be furnished in the form of FDR / DD drawn in the favour of Chief Executive Officer, District Panchayat, Daman and the same should be enclosed with sealed tender document. Tender received without specified EMD shall be summarily rejected. EMD of the Successful Tenderer will be release on issue of certificate from the Horticulture Farm Authority regarding completion of supply of seeds. EMDs of the unsuccessful Tenderers will be released to them within 15 days from the date of opening of Tenders.
- 8 The Seeds to be supplied should be healthy and free for pest & dieses have been produced/ manufactured, packed, labeled and being sold in conformity with the provisions of relevant Acts/ Rules in force.
- 9 The supplies which found to be defective or in damage condition or otherwise not conforming to the given specifications will be rejected. The supplier has to replace the same within specified period of time.
- 10 Interested parties should submit the copy of GST Registration Certificate, PAN Card and Seeds Sales License.
- 11 The Payment will be made through direct bank accounts by RTGS only after successful completion of supply to the satisfaction Chief Executive Officer, District Panchayat, Daman
