- 1. Tenders from registered suppliers having Food Safety license issued by State/UT Government are invited in e-Tendering Two Bids system i.e 'Financial Bid ' and 'Technical Bid'. Both the bids shall applied online through https://ddtenders.gov.in.
- 2. The Tender Fees for an amount of Rs. 1,500/- (Rupees One Thousand Five hundred only) in form of Demand Draft only from any Nationalized / Scheduled Bank drawn in favor of the "The Child Development Project Officer" should be enclosed with the Technical Bid of Tender.
- 3. The Bidder should be a Wholesale Dealer for Pulses, Condiments, Fruits, and Vegetables etc. The Tender should be compulsorily enclosed with documents of an authorized licensee as a Wholesale Agent or Supplier which shall also be <u>uploaded online</u>. III. Supply Procedure & Conditions:-

- 16. The food material supplied should be standard quality in case if found of poor quality on lab analysis, payment shall not be made though the product use by the department.
- 17. The supplier of egg will have to replace the broken/rejected/non-accepted eggs at his own cost and risk.
- 18. The supply shall have to be made in packet form (i.e. corrugated tray) as mentioned in the List of Nutritional Items.
- 19. The supplier will have to provide the Eggs on Weekly basis to the Anganwadi Centers as per the list enclosed as per the order placed for requirement by the department.
- 20. The rate(s) quoted should be inclusive of all taxes, free delivery F.O.R. at all Anganwadi Centre's including Transportation, loading / unloading etc. The rate will be valid & operative for Six month from the date of issue of Supply Order.
- 21. No advance payment or part payment will be made. Payment will be made only after full supply as per Order given.

- 22. In case of failure to Supply of Nutritional items ordered for, as per conditions and within stipulated time, the same will be procured if required, from the bidder who offered next lowest or from any other sources as may be decided by the Tender Inviting Authority and the loss to Government on account of such purchase(s) shall be recovered from the former supplier's E.M.D. or bills payable. The supplier shall have no right to dispute with such procedure.
- 23. If at any time, after the order placed for Supply Nutritional items for any reason whatsoever not require the whole or part of the quantity thereof as specified in the Order, the Tender Inviting Officer shall give notice in writing to supplier. The supplier shall have no any claim for compensation by reason of any alteration which shall involve any curtailment or the supply originally contemplated.

- 28. The Successful tenderer/bidder may be asked to supply Milk (Amul), Egg, Dry coconut, Makhana and Dry Dates to the Anganwadi Centers mentioned in the list annexed herewith as Annexure-A.
- 29. The Supplier should supply quality Agmark and condiments to ensure quality nutritional meal.
- 30. The successful tenderer/bidder shall be responsible for transportation of Nutritional items at points as will be mentioned in work order i.e. Milk (Amul), Egg, Dry coconut, Makhana and Dry Dates up to all Anganwadi Centers as per the list enclosed at his own risk and cost.
