

03. The tenderer will have to produce sample of the items quoted along with tender. Tenders received without sample will be summarily rejected.
04. Tender documents are available in the Office of the Station Fire Officer, Daman on payment of Rs.500/- Non Refundable by cash up to 01/03/2007 at 15.00 hrs.
05. The sealed tender address to the DIGP/Director of Fire & Emergency Services, Daman & Diu, Panch Rasta, Nani Daman - 396 210 should reach him on or before 02/03/2007 up to 15.00 hrs. by courier or by R.P.A.D. The cover should be super scribed as **"TENDER FOR PURCHASE OF UNIFORM KIT ARTICLES DUE DATE 02/03/2007."**
06. The tenders shall be opened on the same day i.e. on 02/03/2007 at 16.00 hrs. if possible in presence of any bidder.
