1.1 Eligibility Criteria for tenderers :-

Only Such contractors need apply, who have :-

- a) Total turn over for execution of Civil Engineering Contractual work valuing one and a half of the cost of work, during preceding three years (from the date of opening of Tenders).
- b) Executed, satisfactorily, at least, one work of a similar nature valuing half of the cost of work during preceding three years (from the date of opening of tender)
- c) Financial solvency of 25% of the cost of the work issued by the State Bank of India or Nationalised Bank or Schedule State Co-operative Banks.

Tenderers should submit strict documentary proof, in regard to these qualifying criteria along with their applications demanding blank tender forms. The application of tenderers who either fail to submit required proof or do not meet the requirements as mentioned (a) to (c) above, will be summarily rejected. The enlistment / Registration of a contractor shall, only, entitle him to be considered for issue of tender papers subject to the conditions laid down herein above, and it shall not confer any right on him either to be necessarily issued the tender papers or award of work.

2.2 The applications for issue of blank tender forms shall be received by the Tender Clerk, in Division Office on **29/05/2007** up to 4.00 pm.

The Tender forms will be available from this office on **30/05/2007** upto 17.00 Hrs. Blank tenders will not be supplied by post.

Valid Income Tax Clearance Certificate shall have to be furnished along with application seeking issue of tender copy.

The tender received without EMD in the form of FDR shall be rejected. FDR shall be accepted only if it is valid for six months (**180 days**) or more after the last date of receipt of tender. The Tender Notice is also available on the web-site :- [daman.nic.in](http://daman.nic.in)
