Limited Tenders duly sealed and superscribed as “ ***Tender for purchase of FRP Umbrella*** ” are invited upto 3.00 p.m. on ***2/01/2007*** which shall be opened on the same day at 4.00 p.m. for the supply and installation of FRP Umbrella mentioned in the schedule on the following terms and conditions.

1. The rates quoted should be strictly for delivery and installation of FRP umbrellas at various beaches / tourists spots. The installation shall be as per the instructions of the Tourism Department. Out stationed shall have to bear the transport charges. No extra charges for packing, forwarding and insurance etc. shall be paid on the rates quoted. Tenders received which do not confirm with the said condition shall be summarily rejected.
2. The rates quoted remain valid and operative for a period of 180 days from the rates of opening of Tender.
3. The rates should be quoted exclusive of all taxes. Only Sales Tax / VAT Tax will be paid of the items on which it is chargeable under the Sales Tax/ VAT Tax. Act. CST will be paid @ 4 % against “D” Form.
4. Earnest money deposit of Rs.25,000/- in the form of FDR drawn in favour of the undersigned should be enclosed with the tender. Tender received without EMD will be rejected out rightly.
5. The rate should be quoted only for the items specified in the schedule and should be for the items of given specification / mark / manufacture. As far as possible illustrated leaflets / catalogue should be enclosed with the tender. Where specification / Mark / Manufacture are not specified the rates should be quoted only for standard quality. The decision of the undersigned for equivalence of specification / Mark / Manufacture shall be final.

6. The Tender should reach to this office of Assistant Director of Tourism, Daman on or before 2/01/2007 at 15.00 p.m. and it will be opened on the same day at 16.00 pm in the presences of the suppliers, if possible.
7. The supply of stores of inferior quality / sub-standard or of different specifications other than that ordered/ specified and or incomplete or broken articles will not be accepted. The supplier will have to replace the same and collect back the rejected articles at his own cost, and risk. In the event of any dispute the decision of the undersigned shall be final and binding on suppliers.
8. Neither any advance payment shall be made nor condition for supply against documents through bank shall be accepted.
9. The FRP Umbrella shall have to be supplied and installed within 45 days from the date of receipt of firm order falling which the EMD shall be forfeited.
10. Right to accept the Tender in full or in part or to reject any or all the tender without assigning any reason there of is reserved with undersigned.
