Schedule-I: Scope of Work

A. System Design

Requirement Definition

To define detailed project requirements after having discussions with concerned officers of Daman, Diu and Dadra & Nagar Haveli Police. This will define the coverage plan also.

Study of Current Infrastructure

To study Police Communication Systems operational at present in the U.T. Administration of Daman, Diu and Dadra & Nagar Haveli.

Site Survey

The Site survey will be carried out by the consultant. The objective of the site-survey will be to decide the requirement & suitability of site.

Concept Formation

A technical strategy will be devised for the network based on the user requirement, site survey etc.

Project Report

To prepare the report covering the following main topics.

1. Technical Design of the Network:

To prepare net work design and identify various components of the network.

2. Financial Analysis:

To work out the estimate the total cost of the Project.

3. O&M Requirement:

To identify the requirements of operation and maintenance of the entire system. Also to identify the requirement of network management and up-gradation of the various components of the system.

4. Interfacing with present HF/VHF Network analysis

Since the project will take place in phased manner, so the consultant will suggest methods to interface with existing HF/VHF Network of Daman- Diu and Dadra & Nagar Haveli Police and methods & equipments for Radio trunking in existing Network.

B. System Specifications

1. Technical Specifications

To submit generic specifications of the systems/components. Technology Survey as and when required will be carried out for preparing the Specifications.

2. Preparation of Pre-qualification Criteria

To prepare detailed eligibility criteria for participation of vendors in various tenders keeping in mind the scope of implementation of this project. The eligibility criteria will mainly consist of :-

- Financial Strength
- Experience and capabilities in the specified field(s)
- O&M and up-gradation capabilities

3. Preparation of Tender Documents

To prepare tender documents as per the project requirements

4. Notice Inviting Tender (NIT)

After obtaining sanction from U.T. Administration of Daman, Diu and Dadra & Nagar Haveli, Daman, Diu and Dadra & Nagar Haveli Police shall float notice inviting tenders and invite bids at its address.

However, in specific cases where the equipment and/or material viz. Surveillance module for interception of messages or any item identified at later a stage to be procured is of secret/confidential nature, open tendering may not be done. In such cases bids will be invited from limited parties from Govt. Public Sector Units.

In some other cases, where equipment is available on DGS&D Rate Contracts. The consultant will assist Daman, Diu and Dadra & Nagar Haveli Police to procure items at DGS&D rates, if so desired by Daman, Diu and Dadra & Nagar Haveli Police.

C. Evaluation of Bids

1. Pre-bid Meeting and Clarification on the Tender

During the period between invitation of a tender and tender submission, many techno-commercial queries may be received. As the project is large, pre-bid meeting will be arranged to clarify the queries/ doubts of the prospective bidders. The consultant will submit answers to all the related queries to Daman, Diu and Dadra & Nagar Haveli Police.

2. Evaluation of Techno-commercial Offers

To evaluate all the bids received against each tender and submit a list of Techno-commercially qualified bidders to Daman, Diu and Dadra & Nagar Haveli Police. The Central Purchasing Committee of Daman, Diu and Dadra & Nagar Haveli Police will thereafter take further necessary action as per codal formalities.

3. Evaluation of Price Offers and Finalization of Bidders

To assist Daman, Diu and Dadra & Nagar Haveli Police in evaluation of the price bids of the Techno-commercially qualified bidders.

Negotiation: To assist in negotiation, if required by the Daman, Diu and Dadra & Nagar Haveli Police, with the bidders.

4. Contracts with Vendors/Contractors

To prepare a draft contract agreement to be signed between the Daman, Diu and Dadra & Nagar Haveli Police and the respective successful Bidders. The contract shall provide sufficient safeguards for Liquidated Damages (LD) for delays.

D. Delivery of Equipment

1. Inspection of the material

To prepare plan and schedule of inspections to be carried out for the equipment and items to be delivered. If required, the consultant may also participate as one of the members of inspection team of Daman, Diu and Dadra & Nagar Haveli Police.

2. Supervision

To visit the sites of manufactures/vendors in order to supervise the development of software/hardware, wherever required.

E. Commissioning

During the implementation stage, the consultant will supervise the work in consultation with Daman, Diu and Dadra & Nagar Haveli Police. The consultant will be responsible for monitoring the progress of the project, to ensure that the project is implemented as per the desired technical specification and design. The consultant will be required to submit monitoring report regularly to Daman, Diu and Dadra & Nagar Haveli Police.

As and when various modules of the project are completed. The consultant will be required to carry out necessary tests in order to ensure that each module conforms to the requirement.

During the implementation stage, the consultant will be involved in the following activities.

1. Site Preparation

The consultant will assist Daman, Diu and Dadra & Nagar Haveli Police in site preparation

2. Installation

The consultant will supervise the installation work as per the technical requirements.

3. Supervision of Training of Manpower

The consultant will make training schedule and see to it that proper training is imparted to Daman, Diu and Dadra & Nagar Haveli Police employees for operation and maintenance through vendors

4 Acceptance Testing

The consultant will participate in the acceptance testing of the systems. Bidder will have to demonstrate functional guarantees made by them as per the technical requirement of the bid. Acceptance Test for Systems shall include running the Systems (meeting the standards of performance) for a period of 30 (thirty) consecutive days.

5. Commissioning

The consultant along with the notified inspection team of Daman, Diu and Dadra & Nagar Haveli Police will supervise the commissioning of the systems as per the requirements. Within two weeks from the end of the Acceptance Test, Daman, Diu and Dadra & Nagar Haveli Police's project manager shall certify Acceptance / Rejection of the Systems under test. The date on which Final Acceptance Certificate is issued shall be deemed to be the date of successful commissioning of the Systems.

F. Deliverables of the Project

- The consultant will submit the System Design Report consisting of system study, requirement analysis, network design, identification of components, project cost and benefits etc.
- The consultant will submit the RFP document consisting of technical specifications of the equipments and eligibility criteria for pre-qualification of vendors assist in evaluation of bids and submit draft contract document to be signed with successful bidders.
- The consultant will submit inspection/test plan(s) and schedule(s) for carrying out the Factory Acceptance Test.
- The consultant will supervise installation & commissioning and will submit regular projects status reports and test report.

G. Completion of Project

The project will be declared completed with commissioning of the system.
