

MINUTES OF THE MEETING OF DAMAN & DIU COASTAL ZONE MANAGEMENT AUTHORITY HELD ON 11/02/2021 AT 11.30 AM AT CONFERENCE HALL, SECRETARIAT, MOTI DAMAN.

The Daman & Diu Coastal Zone Management Authority held its meeting on 11.02.2021 at the Conference Hall under the Chairmanship of Dr. A. Muthamma, Chairman, DDCZMA at 11.30 am. The outstation members attended the meeting online through videoconferencing.

At the outset, the Member Secretary welcomed the chairman and all members and with the permission of the chair proceeded with the meeting.

The previous Minutes of the meeting of Daman Diu Coastal Zone Management Authority (DDCZMA) held on dated 07/02/2020 was discussed and approved. Thereafter the new agenda were discussed and deliberated as under;

AGENDA ITEM NO. 1 : PREPARATION OF COASTAL ZONE MANAGEMENT PLAN OF THE UT OF DAMAN & DIU AS PER CRZ NOTIFICATION NO. GSR-37(E) DATED 18/01/2019.

The DDCZMA in its meeting held on dated 02/03/2019 has decided that the Coastal Zone Management Plan based on CRZ Notification 2019 will be prepared by NCSCM, Chennai. Accordingly, the work has been awarded to NCSCM, Chennai for preparation of Coastal Zone Management Plans (CZMPs) in accordance with the CRZ Notification, 2019. An amount of Rs. Rs. 18,80,803.00 (Rupees Eighteen Lakh Eighty Thousand Eight Hundred and Three only) as first instalment has already been released to NCSCM on 12/02/2020.

The Director, NCSCM on 8.2.2021 has submitted the pre draft Coastal Zone Management Plans (CZMPs) of Diu and Daman as per CRZ Notification, 2019 and requested to provide the following data required for finalization of CZMP.

1. Population density data and census village boundary as per census 2011 required for CRZ IIIA and CRZ IIIB Classification for the villages of Daman and Diu
2. Eco-tourism plans and temporary tourism facilities along the beaches such as shacks, toilets or washrooms, change rooms, etc, if any.
3. Existing authorized developments/structures on the seaward side and features like cyclone shelters, rain shelters, helipads and other infrastructure including road network for the purpose of rescue and relief operations during cyclones, storms, tsunami and the like.

Further, NCSCM, Chennai has also informed that the data/information given below have been used for preparation of CZMP and informed that if any data need to be updated, the same has to be provided in shapefile format.

1. National Highways and State Highways in coastal areas
2. Notified ports and port limit boundaries.
3. Fishing village boundaries, fish breeding areas, fish landing centres, fish drying areas, fishing zones in the water bodies, etc.
4. Infrastructure facilities such as roads, jetty, port, fish landing centres, harbour, lighthouses, blue flag area, tourism potential area, etc. to be provided to NCSCM.
5. Copies of Govt. notifications of new Municipalities, if any.

The Member Secretary informed that the details on the above points will be collected from the respective line departments and the District Administration and forwarded to NCSCM for incorporation and finalisation. Director, NCSCM, Chennai suggested to conduct an internal meeting with the line departments namely Town Planning, Municipal Councils, Public Works Department, Tourism Department, Port Office, Fisheries Dept etc. and the data in shape file may be provided to NCSCM, Chennai to complete the preparation of Draft CZMP for Daman & Diu as per CRZ Notification 2019.

Director, NCSCM also informed that couple of beaches from Daman & Diu may be included for the Blue Flag Certification.

DDCZMA has agreed on the above and asked the Member Secretary to take follow up and get the details from all line departments at the earliest and forward the same to NCSCM, Chennai.

AGENDA ITEM NO. 2 CRZ CLEARANCE FOR NEW CIRCUIT HOUSE BUILDING ON SEA FACE ROAD, NANI DAMAN AREA : PTS NO. 45/58, NANI DAMAN SIZE OF PROJECT: 3945.15 SQ. MTS. (GF+6 STOREY) (FTS : 75948) (FILE NO. 2/2/AE/PWD/SD-II/2018-19/)

The Executive Engineer, WD-II, PWD, Daman submitted a proposal for seeking CRZ clearance for New Circuit House Building on Sea Face Road, Nani Daman (Area :

PTS No. 45/58, Nani Daman Size of Project: 3945.15 Sq. Mts. (G+6 Floors)) in File No. 2/2/ AE/PWD/SD-II/2018-19/ alongwith documents namely a) Form-1, b) Rapid EIA Report including marine and terrestrial component except for construction projects listed under 4(c) and (d) and c) Disaster Management Report, Risk Assessment Report and Management Plan.

The Proposal was referred to the District Level Committee, Daman and DLC recommended the proposal in its meeting held on 28/02/2019 and referred to DDCZMA. As per the minutes of the District Level CRZ Committee Meeting held on 28/02/2019, the project falls in CRZ II and the construction is already completed and is on the landward side of the existing road and other structures and the activity is permissible as per CRZ notification. The circuit house was essential to cater to the increasing flow of officials visiting Daman and Diu and the proposal is made for ex post facto CRZ clearance.

The Daman & Diu Coastal Zone Management Authority in its meeting held on 02/03/2019 agreed to the proposal in principle and decide to forward the case to the MoEF& CC for *ex-post facto approval* subject to submission of all the remaining documents namely i) CRZ map in 1:4000 scale, drawn up by any of the agencies identified by the Ministry of Environment, Forest and Climate Change vide its Office Order number J-17011/8/92-IAIII, dated the 14th March, 2014 using the demarcation of the HTL or LTL, as carried out by NCSCM, ii) Project layout superimposed on the CRZ map duly indicating the project boundaries and the CRZ category of the project location as per the approved Coastal Zone Management Plan under this notification and iii) the CRZ map normally covering 7 kilometre radius around the project site also indicating the CRZ-I, II, III and IV areas including other notified ecologically sensitive areas.

The I/c Executive Engineer, PWD, WD-I, Daman vide letter No. EE/PWD/WD-I/DMN/2019-2020/3896-A Dated 12/08/2019, has submitted the documents namely a) the proposed construction of New Circuit House Building on Sea Face Road at Nani Daman, UT of Daman falls in CRZ-II as shown in the CRZ map of 1:4000 scale, the CRZ map of the Project site, the Google imagery showing the proposed Construction of New Circuit House Building on Sea Face Road at Nani-Daman and the Report of the Anna University, Chennai.

The Daman & Diu Coastal Zone Management Authority in its meeting dated 17/09/2019 deliberated the issue and decided to forward the proposal to the MoEF & CC for ex post facto approval for construction of Govt. Circuit House as the activity is permissible activity and falls in the developed area of CRZ-II and no other rules and guidelines have been violated.

Accordingly, the proposal seeking Ex-Post facto approval for CRZ clearance for New Circuit House Building on Sea Face Road, Nani Daman has been forwarded to the Member Secretary, NCZMA, MoEF & CC, New Delhi vide letter No. 2/2/AE/PWD/SD-II/DMN/2018-19/938 Dated 05/11/2019 for approval along with the necessary documents.

In response, the Director (CRZ), MoEF&CC requested the EE, PWD, WD-I, Daman vide letter F. No. 19-127/2019-IA.III(I) Dated 10/12/2019, to upload the Proposal in PARIVESH portal of the MoEF & CC under item "Only CRZ Clearance" along with all statutorily required documents as prescribed in Para 4.2 of CRZ Notification-2011. A Copy of the said letter is also marked to the MS, DDCZMA, Daman.

The DDCZMA, Daman vide letter No. 2/2/AE/PWD/SD-II/DMN/2018-19/420 Dated 26/12/2019 forwarded the communication received from MoEF & CC dated 10/12/2019 to the Executive, Engineer, PWD, WD-I, Daman for necessary action.

As informed by the I/c Executive Engineer, Public Works Department, Daman submitted the CRZ proposal in PARIVESH portal vide proposal No. SW/139527/2020 In response, an EDS was sought by MoEF & CC on 14/09/2020 and the same is reproduced below.

"As per the extant norms of the CRZ Notification, 2011, construction projects involving less than 20000 Sqm. built up area in CRZ-II, shall be approved by the concerned State of Union Territory planning Authorities in accordance with the CRZ Notification after obtaining recommendations from the concerned CZMA. Accordingly, the proposal requires clearance from concerned Town Planning Authority"

The Executive Engineer, PWD, WD-I, Daman vide letter No. EE/PWD/DMNWD-I/TB/20-21/4765 Dated 21/09/2020, requested the Chief Town and Country Planner, Town & Country Planning Department, Daman for necessary clearance.

The Chief Town and Country Planner, Town & Country Planning Department, Daman vide letter No. 15/PDA/DMN/New Govt. Circuit House/343/2020/1317 Dated 01/10/2020 informed the EE, PWD, WD-I, Daman that the competent authority for approval of building permission in the Urban/Municipal area of Daman is the Daman Municipal Council. And requested to forward the proposal for approval to the concerned local authority viz. the Daman Municipal Council.

The Executive Engineer, PWD, WD-I, Daman vide letter No. EE/PWD/DMN/WD-I/TB/20-21/5054 Dated 07/10/2020, requested the Chief Officer, Daman Municipal Council, Daman for necessary clearance/approval.

The Joint Secretary PWD and AE, III, PWD present during the meeting informed that the activity which is otherwise permissible under the provisions of CRZ Notification and there is no violation of CRZ norms and prior approval is not obtained due to oversight and he assured that such lapses will not happen in future and prior approval will be taken before the commencement of the projects. All the members have opined that PWD should be issued with a warning not to take up any projects in CRZ areas without prior clearance/approval.

As per the norms of CRZ Notification 2011 for regulation of activities permissible under CRZ II include namely Buildings shall be permitted on the landward side of existing authorised structures, buildings permitted on the landward side of the existing and proposed roads or existing authorised structures shall be subject to the existing local town and country planning regulation including the existing norms of Floor Space Index or Floor Area Ratio: provided that no permission for construction of buildings shall be given on the landward side of any new roads which are constructed on the seaward side of an existing road. Reconstruction of authorised building to be permitted subject to existing Floor Space Index or Floor Area Ratio norms without change in present use.

The Circuit House building of PWD falls in CRZ II and is on the landward side of the existing road and other structures and the activity is permissible as per CRZ notification and there is no violation of CRZ norms. The total plot area is 2326 and built-up area is 3945.15 Sq.m and FSI permissible as per DCR is 2.00 and Achieved is 1.696.



The proposal is discussed at length in view of the observations made by MoEF&CC that construction projects involving less than 20000 sq.m built up area in CRZ II shall be approved by the concerned State or Union Territory Planning Authority in accordance with the CRZ notification after obtaining recommendations from the concerned CZMA. All the members of DDCZMA, looking at the extant norms, agreed to recommend the New Circuit House building at Nani Daman for approval/clearance of the Town and Country Planning/local authorities with the following conditions.

Management of Solid Wastes in accordance with Solid Waste Management Rules, 2016 shall be strictly implemented.

All liquid wastes arising from the building will be disposed of as per the norms prescribed by Central Pollution Control Board/Pollution Control Committee (PCC), DNH&DD. There shall not be any disposal of treated/untreated sewage/waste water into the sea/coastal water bodies.

There shall be regular monitoring of standard parameters of the sewage treatment in STP and ensure that the STP is effectively and efficiently functioning and treated waste water falls within the norms prescribed by CPCB/PCC, DNH&DD. The treated waste water shall be effectively utilised for gardening and other activities.

Hazardous wastes generated from the generator shall be disposed as per applicable rules/norms.

Consent to Establish and Consent to Operate shall be obtained from the Pollution Control Committee, DNH&DD under the Provisions of Water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981 as may be applicable.

All other statutory clearances shall be obtained by PWD as applicable from the respective competent authorities.

Environmental statement for each financial year ending 31st March, in Form V is to be submitted by the PWD to the Pollution Control Committee, DNH & DD as prescribed under the Environment (Protection) Rules as amended.

The DDCZMA unanimously recommended for issue of post facto clearance for New Circuit House Building on Sea Face Road, Nani Daman (Area: PTS No. 45/58, Nani Daman Size of Project: 3945.15 Sq. Mts. (G+6 Floors)).

AGENDA ITEM NO. 3 : CRZ CLEARANCE FOR WALK IN AVIARY AT JAMPORE RESERVED FOREST AREA (SY. NO. 70 & 71 OF VILLAGE JAMPORE), MOTI DAMAN.

The MoEF & CC has issued CRZ Clearance for establishment of Walk in Aviary with exotic Birds at Sy. No. 70 & 71 of Village Jampore, Jampore Reserved Forest Area, Moti Daman vide letter F. No. 11-37/2020-IA-III Dated 16/10/2020, received from Dr. H. Kharkwal, Additional Director/Scientist 'E' (CRZ), MoEF & CC, New Delhi.

The DDCZMA noted the clearance and the same shall be kept in records.

The meeting ended with vote of thanks to the Chair.
