OFFICE MEMORANDUM

Government of India as well as UT Administration from time to time has been issuing instructions to execute all Government transactions through e-Payment only.

- (2). Recently, direct cash transfer scheme has also been introduced with respect to all the schemes being implemented in this UT Administration and payments are being transferred into the account of beneficiaries directly.
- (3). In order to streamline the payment, bring transparency as well as to obviate any kind of harassment either to beneficiaries or contractor/supplier or any person who is required to get payment or cash incentives from UT Administration, it has been decided that all kinds of payment, which inter alia includes payment to contractors/suppliers, old age pension, widow pension, physically disabled pension, stipend, student scholarship, subsidies etc. will be made w.e.f. 1st February, 2013 through E-payment directly into the account of the beneficiaries.
- (4). It is hereby directed that any kind of monetary transaction by the UT Administration, which includes all government department, local bodies (District Panchayat Daman and Diu, District Panchayat Dadra & Nagar Haveli, Daman Municipal Council, Diu Municipal Council and Silvassa Municipal Council), all autonomous bodies like OIDC Ltd., SC/ST Corporation etc. shall be made through E-payment directly into the accounts of the persons/firms entitled to such payment, with effect from 1st February 2013.
- (5). It shall be the responsibility of the Drawing and Disbursing Officers concerned and Head of Office to ensure the strict compliance of above instructions.
