In exercise of the powers conferred by the provision to Article 309 of the Constitution of such read with Ministry of Home Affairs Order No.7/1/65-EAs(A) dated 16/02/1965 and Department of Personnel & Training, O.M. No. AB/14017/61/2008-Estt(RR) dated 24/03/2009 and in supersession of the existing Recruitment Rules for the post and all other powers enabling him in this behalf, the Administrator of Daman and Diu is please to make the following Rules relating to recruitment to the post of 'Group Instructor', General Central Services, Group 'B' (Non-Gazetted / Non-Ministerial) in Govt. Industrial Training Institute, Daman under U.T. Administration of Daman and Diu namely:

1. Short Title Application and Commencement :

- (I) These rules may be called the Administration of Daman and Diu, Group Instructor, General Central Services, Group 'B'(Non-Gazetted / Non-Ministerial) post, Recruitment Rules, 2011.
- (II) These rules shall apply to the posts specified in column 1 of the Schedule to these Rules.
- (III) These rules will come into force in the date of their publication of this Notification in the Official Gazette and will relate to appointment to various post made on or after this date. -

2. Number of posts, classification and Scale to Pay :

The number of posts its classification and the scales of pay attached thereto shall be as specified in column 2 to 4 of schedule annexed to these rules. Provided that, the Administrator of Daman and Diu may vary the number of posts in column 2 of the said schedule from time to time subject to exigencies of work.

3. <u>Method of Recruitment, Age limit and Other Qualifications etc :</u>

Method of Recruitment of the said posts, age limit, qualification and other matters connected therewith shall be as specified in columns 5 to 13 of the schedule.

4. Disqualification :

No person (a) who has entered into or contracted a marriage with a person having a spouse living, or (b) who, having a spouse living has entered into or contracted a marriage with any person shall be eligible for appointment to the said posts provided that Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and other party to the marriage and that there are other grounds for so doing, exempt any personfrom the operation of this rule.

5. <u>Power to relax :</u>

Where the Administration is of the opinion that it is necessary or expedient so to do, it may by order and for reasons to be recorded in writing **and in consultation with the Union Public Service Commission** relax any of the provisions of these rules with respect to any class or category of persons.

6. <u>Saving</u>:

Nothing in these rules shall effect reservations, relaxation of age limit and other concessions required to be provided for Schedules Caste and Scheduled Tribes, Ex-servicemen and other Special Categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
