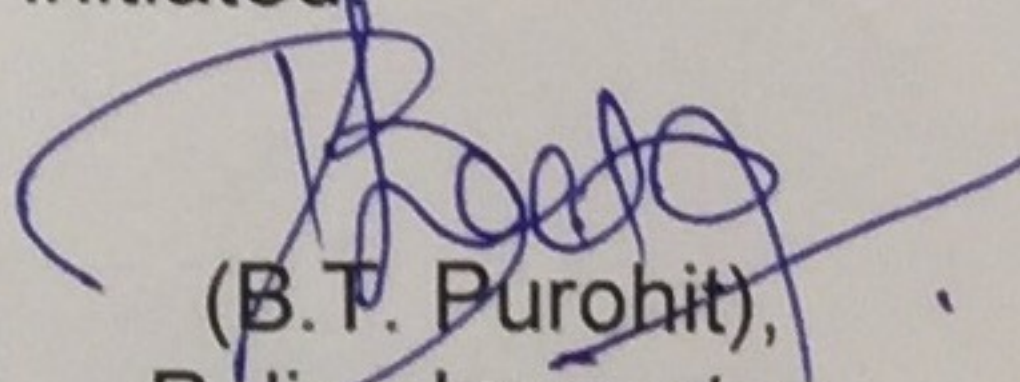
Sub: Unclaimed / Abandoned Vehicles seized by Daman Police.
