**OFFICE MEMORANDUM**

**NOTIFICATION**

In exercise of the powers conferred by the proviso to Article 309 of the constitution, with Government of India, Ministry of Home Affairs, Order No.7/1/65-Estt.(A), dated 16<sup>th</sup> February, 1965 and Ministry of Home Affairs Notification No.3(4)/65-GP, dated 27<sup>th</sup> January, 1965 read with Department of Personnel and Training Notification No.39023/02/2015-Estt(B), dated 25<sup>th</sup> May, 2017 and in supersession of the existing Recruitment Rules for the posts and all other powers enabling him in this behalf, the Administrator of UT of Dadra and Nagar Haveli and Daman and Diu hereby makes the following rules relating to the recruitment of General Central Services, Groups 'B' (Non-Gazetted/Non Ministerial) post of **Skipper (Inspector)** (sanctioned under Coastal Security Phase-II) in the Police Department, Administration of Dadra and Nagar Haveli and Daman and Diu namely.

**1. Short title, application and commencement :**

- (i) These rules may be called the Administration of Dadra and Nagar Haveli and Daman and Diu, Group 'B' (Non-Gazetted/Non-Ministerial) posts of Skipper (Inspector) Recruitment Rules, 2022.
- (ii) These rules shall apply to the posts specified in column 1 of the Schedule to these rules (hereinafter called the said schedule).
- (iii) These rules will come into effect from the date of publication of this notification in the Official Gazette and will relate to appointment to the various posts made on or after this date.

**2. Number, classification and level of Pay Matrix :-** The number of posts, classification and the level of pay matrix attached thereto shall be as specified in columns 2 to 4 of the Schedule annexed to these rules.

Provided that, the Administrator of Dadra and Nagar Haveli and Daman and Diu may vary the number of posts in Column 2 of the said Scheduled from time to time subject to exigencies of work.

**3. Method of recruitment, age limit and other qualification etc.:** The methods of recruitment to the said posts, age limit, qualification and other matters connected there with shall be as specified in Columns 5 to 13 of the aforesaid schedule.

4. **Disqualification :**

No person (a) who has entered into or contracted a marriage with a person having a spouse, living or (b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the service.

Provided that the Administrator of Dadra and Nagar Haveli and Daman and Diu, may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. **Power to relax :**

Where the Administrator of Dadra and Nagar Haveli and Daman and Diu is of the opinion that, it is necessary or expedient so to do, it may, by order, and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

6. **Saving :**

Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for Scheduled Castes, Scheduled Tribes, Other backward Class, Ex-Servicemen and other special categories of persons in accordance with the orders issued by Central Government from time to time in this regard.
