

M/s. Fit Tight Fastners (Unit-I), Gala no. 29 to 33, Sr. no. 264/2, Siddha Industrial Estate, Village - Dadra, Silvassa. was issued Consent to Establish for manufacturing of "Wires, Rivets, Stud, Screws, Nuts, Nails, Anchor fastners, Turn Components, Press components, Auto Parts, fabricate items, wire mesh, self net parts, Spring and Wires- 3600 TPA (without pickling, acid treatment) (no other items)." under Water and Air act valid upto 30/06/2015. The activity falls under **Category-III**.

The unit has submitted application for grant of Consent to Operate under Water and Air act on 23/05/2016 along with the following documents;

- Application form no. XIII under Water Act.
- Application form no. I under Air Act.
- Declaration giving details of capital investment including land, building and plant & machinery without description.
- Consent fees under water and air act for Rs. 11,800/-.
- Format installed Environmental Display sign board.
- Application for authorization to handle Hazardous Waste (form-I).
- Industry Data Sheet.
- Copy of Consent to Establish under Water and Air Act.
- Form-I of Recycled Plastic Manufacturing and Usage (Amendment) Rules, 2003 for grant of registration for manufacturing of plastic carry bags and containers.

The unit had submitted demand draft of Rs. 11,800/- whereas actual Consent to Operate fee is Rs. 32,700/-.

The unit was inspected on 05/07/2016 at 14:00 hrs. At the time of inspection of the unit following observations were noted:

- Display sign board was not installed at the entrance gate.
- The unit was in operation at the time of inspection.
- Raw material used in manufacturing process was stainless steel and Mild steel wire roll.
- Products being manufactured at the time of inspection were Screws.
- Machineries installed in the unit were 4 Press machines, 16 Rolling machines and 34 Header machines.
- Representative of the unit had informed that they sell the generated metal scrap to the authorized recycler.
- Housekeeping observed was good.
- Proper storage facilities were available for raw material and products.
- The unit is not significant to pollution potential. As there is no water used during any stage of process.

Based upon the scrutiny of the submitted documents and consent fee along with the Consent to Operate application and observations during the time of inspection a query letter is prepared and placed in the file regarding installation of Environmental display sign board and remaining consent fee of Rs.20,900/-.
