**M/s. Solaris Speciality Chemicals Private Limited**, Sr. no. 61/2, Plot. no. 13, Near Zandu Pharma, Village- Masat, Silvassa, UT of Dadra & Nagar Haveli was issued Establishment Consent for manufacturing of "Black master batches – 10000 MT/Annum, Colour Master batches – 5000 MT/Annum and Polymer Compounds – 5000 MT/Annum. (No other items)" under Water Act and Air Act valid upto 30/04/2017. The activity falls under **Category-III**.

The unit had submitted application for grant of Consent to Operate under Water and Air act on 19/08/2016 along with the following documents:

- Application form no. XIII under Water Act.
- Application form no. I under Air Act.
- Copy of operate consent under Water and Air Act.
- Declaration giving details of capital investment including land, building, plant and machinery without description.
- Consent fees Rs. 30,000/- under Water and Air Act
- Form – I application for authorization to handle hazardous wastes.
- Industry date sheet format.
- Format of installed display sign board.

The unit was inspected on 27/09/2016 at 13:00 hrs. At the time of inspection of the unit following observations were noted:

- Display sign board was properly filled with product and waste generation details.
- The unit was under machinery installation phase.
- The unit has not bought any raw material till date for production purpose.
- The unit had bought an extrusion line machine, an air compressor and a cooling tower in the premises of the unit but has not installed it completely so that production can be initiated for trial.
- The unit was availed with septic tank and sock pit for domestic waste water generated.

Based upon the above mentioned observations during the time of inspection a query is prepared and placed in the file.

The unit had submitted reply on 11/11/2016 against the issued query letter vide no: G-6252/MS/WA/AA/15-16/395 dated 05/10/2016. The unit had informed that they had installed all the necessary machinery to start the production and also submitted photographic proof of installed machineries.

Based upon the submitted details unit was re-inspected on 29/11/2016 at 11:30 hrs. At the time of inspection of the unit following observations were noted:

- Display sign board was properly filled with product and waste generation details.
- The unit was not operational at the time of inspection.
- Raw materials utilized for production were granules of PET and carbon powder.
- Manufacturing process mainly involves extrusion.
- Manufactured final product of the unit observed during the time of inspection was polymer compound.
- The unit had installed an extrusion line machine, a grinder, a blender and a pulverizing machine in its premises for production purpose.
- Proper storage facilities were available for raw material and products.
- The unit was availed with septic tank and soak pit for domestic waste water generation.
- Housekeeping observed was good.

In view of the above, Consent to Operate (Category-III) may be approved to manufacture "Black master batches – 10000 MT/Annum, Colour Master batches – 5000 MT/Annum and Polymer Compounds – 5000 MT/Annum. (No other items)" under Water Act and Air Act along with terms and conditions as mentioned in annexure-I for period up to 31/10/2017.
