No. AB-14017/20/2008-Estt(RR) dated 17th May, 2010, the Administrator of Daman & Diu is pleased to makes the following Rules relating to recruitment to the General Central Service Group "C" (Non Gazetted,) (Ministerial) Common Cadre Post of Lower Division Clerk/Student Section Clerk/Hostel Rector/LDC-cum Cashier in the Administration of Daman & Diu namely:-

1. SHORT TITLE, APPLICATION AND COMMENCEMENT:

- (i) These Rules may be called the Administration of Daman and Diu, Group 'C' (Non-Gazetted Ministerial), Common Cadre Posts of Lower Division Clerk/Student Section Clerk/Hostel Rector/LDC-cum Cashier, Recruitment Rules, 2014.

Nothing in these rules shall affect reservation, relaxation of age limit and other concession required to be provided for the Scheduled Castes and Scheduled Tribes, and other special categories or persons in accordance with the orders issued by the Central Government from time to time in this regard.
