## NOTIFICATION

In exercise of the powers conferred by Section 140 of Daman and Diu Town & Country Planning (Amendments) Regulation, 1999 (Read with Principle Act–Goa, Daman and Diu Town and Country Planning Act, 1974) and all other powers enabling in that behalf, the Administrator of Daman and Diu is pleased to amend the Development Control Rules–2007 of Daman district as under:

- 1. Short Title, Extent and Commencement: These rules shall be called as "Development Control Rules (Amended), 2014 of Daman district" and shall be applicable to entire Panchayat area of Daman district in UT of Daman and Diu. It shall come into force from the date of its publication in the Official Gazette of Daman & Diu.
- 2. **Definitions of Terms and Expressions:** The terms and expressions not defined in these rules shall have the same meaning as in the Daman and Diu Town & Country Planning (Amendment) Regulation, 1999 (Read with Principle Act—Goa, Daman and Diu Town and Country Planning Act, 1974).
- **3.** Amendment in Clause 3: In Sub-Clause (24) of Clause 3, the definition of the Competent Authority shall be substituted as under:

Competent Authority : means Planning & Development Authority.

After Sub-Clause 3.85, the following Sub-Clause shall be inserted:

Sub-Clause 3.85(A): Planning & Development Authority: Means the Authority formed under Section 20 of the T & CP Act of Daman and Diu.

The Sub-Clause (104) of Claluse 3 shall be deleted.

4. Amendment in Clause 7: The following Para shall be added after first Para in Sub-Clause (1) of Clause 7:

**Scrutiny Fee:** Every application submitted for scrutiny of development proposals submitted by the owner/submission of building plans for approval, scrutiny fee shall be paid by the owner/applicant as indicated below:

(a) For the first submission of building plans/Layout Plans etc. within a period of one year i.e. without extension of time limit, and/or within the extended period, duly granted by the Authority, the scrutiny fee payable shall be as follows:

- (i) Up to 1000 Sq.mts
- Rs. 500/-
- (ii) 1001 sq.mts to 2000 sq. mts Rs. 1000/-
- (iii) More than 2000 sq.mts
- Rs. 1 per sq.mt.
- (b) Any request/application for re-validation, revision of development proposals, revised building plans/Layout plans etc. for approval shall be accompanied by payment of scrutiny fee at the rate of Rs. 2/- per sq.mt of proposed built up area and/or total area if it is layout approval, subject to minimum of Rs. 500/- or Rs. 1/- per sq.mt whichever is higher. Further, if the built up area is more than 100 sq.mt the amount so calculated of the built up areas shall be rounded to next Rs. 10/-

Sub-Clause 7.2 of Clause 7 shall be deleted.
